When the escort intervenes to save the poor lady and children, he is blamed for having bad

This fight further messes up when a drunken man after losing senses damages his household property as well. The play unfolds a series of incidents where people influenced by drugs, alcohol and other intoxications create hell for themselves as well as for others. Many precious lives are being charred in this fire of drug menace which is to be fought unitedly. Through this play Balwant Thakur has tried to make an appeal to save mankind from this dragon.
