Whereas, it has been observed that some motor vehicles having registration numbers of other States/Union Territories, though owned by residents of Ramban District, are being continuously kept and plying in the District beyond the permissible time period, without obtaining re-registration from the registering authority, Ramban.

Whereas, such act constitutes a contravention of the provisions of Section 47 of the Motor Vehicles Act, 1988, which mandates that when a motor vehicle registered in one State or Union Territory is kept in another State or Union Territory for a period exceeding twelve (12) months, the owner thereof shall apply in the prescribed manner to the registering authority of the latter State/Union Territory for assignment of a new registration mark;

Whereas, non-compliance with the aforesaid statutory requirement adversely affects the effective, regulation, vehicle traceability, enforcement mechanisms and poses potential risks to public safety, law and order and internal security; and

Now, therefore, in exercise of the powers conferred under the Motor Vehicle Act, 1988, Central Motor Vehicles Rules, 1989 and in the interest of public safety, internal security and effective enforcement of law, it is hereby notified that all person residing in District Ramban having motor vehicles bearing registration numbrs of other States/Union Territories, which are being kept and plied within Ramban District beyond the permissible time period, shall apply for assignment of new registration mark before the Registering Authority Ramban within a period of fifteen (15) days from the date of issuance of this Public Notice. It is further notified that on the expiry of the aforesaid period, any vehicle found plying within the Ramban District in violation of the provisions of Section 47 of the Motor Vehicles Act, 1988, shall be challaned/seized and penalties will be levied as per the provisions of M.V Act, 1988 and the Rules framed thereunder, without any further notice.
