He noted that Ladakh's land records are being modernised through a technology-driven system to



Udhampur district. These schools were identified for renovation and upgradation following a detailed assessment of damages caused by adverse weather conditions. Priority was accorded to institutions where essential infrastructure such as classrooms, boundary walls and sanitation facilities had been severely affected.
