## Army trains VDGs...

17 remote villages along the Doda-Chamba border, including women volunteers, are undergoing intensive training in handling automatic rifles, minor tactics, self-defence, bunker construction and repelling enemy attacks, they said.

The villages are located near the forested and mountainous areas where security forces are currently conducting extensive search operations in view of suspected terrorist movement.

The training is being conducted at Shingini panchayat of Bhalessa, around 90 km from the Doda district headquarters, to equip volunteers with the necessary skills to protect their vilages and act as a first line of defence, especially in vulnerable areas, an official said.

He said the move complements the ongoing operation by the Army, police and paramilitary forces in the higher reaches to track down and neutralise the terrorists who had managed to infiltrate into Chenab valley, especially Doda and Kishtwar districts, a couple of years back.

According to officials, the VDGs welcomed the training and the recent upgradation of their weaponry. They expressed gratitude to Union Home Minister Amit Shah for providing selfoading rifles (SLRs), replacing the older .303 rifles, which they said, has significantly boost-

"This is a major programme bringing together members from 17 Village Defence Groups. We are being trained in weapon handling, bunker construction and self-defence. Receiving such training at our doorstep is highly appreciable," Surinder Singh, a VDG member from Shingani,

(TDPI), through its director Ranjeet Prasad, conducted a recruitment campaign and select-

ed 1,300 trainees in Kashmir, a spokesperson of the Economic Offences Wing said. The trainees alleged that they were promised a monthly salary ranging from Rs 5,000 to Rs 12,000, but were instead required to deposit a registration fee of Rs 2,400 per person, he said.

The TDPI collected the registration fee but paid no salary to the trainees. "During investigation, it was prima facie established that the company allegedly defrauded

"The investigation, supported by both oral and documentary evidence, has been concluded as proved against the accused Ranjeet Prasad," the spokesperson added.

He said that as the accused failed to cooperate with the investigating agency and could not be traced at his given address at Gopalganj in Bihar, the chargesheet was submitted in absentia by initiating proceedings under Section 512 of Criminal Procedure Code, which allows a court to record witness testimonies in the absence of an absconding accused.

"The accused were found to be actively propagating content prejudicial to the sovereignty and integrity of India, spreading false and fabricated narratives with the clear intent of instigating disaffection against the Union of India," the official said.

The officials said warrants of arrest were issued against the accused persons, who went underground and are absconding to evade the process of law.

Taking serious note of their deliberate evasion, the court has now issued a proclamation unde Section 82 CrPC, directing the accused to appear before it on or before January 31, 2026.

"Failure to comply will invite stringent proceedings under Section 83 CrPC, including attach ment of property," the official said.

According to the officials, despite being declared absconders, the accused are notorious for their continued hostile activities and remain highly active on social media platforms, where they persist in peddling false, fabricated and provocative content with the intention of "inciting large-scale violence and destabilizing public order" in the Union Territory of Jammu and

# Woman's culpable homicide case closed after being stuck in courts for 46 years

SRINAGAR: The High Court of Jammu and Kashmir and Ladakh has closed the proceedings of a case which was registered 46 years ago and set free the woman, now 70 years of age, who was convicted on charges of culpable homicide not amounting to murder.

Shameema Begum, a resident of Uri in Baramulla district of Jammu and Kashmir, was arrested on charges of causing grievous injuries to her husband's grandmother during a scuf fle with her mother-in-law in 1979. The victim died four days after the incident and the state pressed murder charges against the accused. However, during the course of the trial -- which lasted 30 years, Begum was convicted under Section 304-II of IPC and sentenced to five years rigourous imprisonment in 2009. She appealed against the sentence before the High Court the same year and sought reduction in the jail term. Justice Sanjay Parihar quoted several Supreme Court judgements while disposing off the case and set free the 70-year-old woman.

"At the time of admission of the appeal, the appellant had expressed her intention not to challenge the conviction and sought consideration of release on probation under Section 562 CrPC However, the State indicated its intention to file an appeal, which was never pursued," the court observed in its five-page order.

It said the offence was committed in a heat of passion without premeditation. "The appellant has suffered incarceration and the ordeal of prolonged proceedings for over 46 years, and that she is now about seventy years old with age-related infirmities, this court is of the considered view that no useful purpose would be served by maintaining the substantive sentence," Justice Parihar said. "As no minimum sentence is prescribed under Section 304-II RPC, the ends of justice would be served by treating the sentence as already undergone and payment of a fine of Rs 5,000, in default thereof, to undergo simple imprisonment for three months," he added. Justice Parihar said this case bears testimony to the systemic delay in the disposal of crimina cases. He said the court must consider both aggravating and mitigating circumstances while sentencing. "Sentencing must strike a balance between deterrence, incapacitation, and rehabilitation as the absence of one defeat the purpose of the others," the judge said. Applying the aforesaid principles to the present case, it is evident that the incident occurred on July 10,1979, the trial continued for more than thirty years culminating in conviction on July 16,2009, and thereafter another it took sixteen years for disposal of the appeal, he said. Justice Parihar said though such delays cannot ordinarily ensure benefit of a convict and the court cannot remain oblivious to the reality of prolonged pendency of criminal cases, wherein accused persons remain entangled in the criminal justice system for decades. "Sentencing, in the pres ent context, must focus on reform and rehabilitation, enabling the offender to realize the wrong committed," he added.

## Forest guard killed in stone slide incident

## Notorious drug peddler detained under PITNDPS

DODA: Taking stringent action against a notorious drug ped dler, Doda Police has detained him under the Prevention of Illicit Traffic in Narcotic Drugs and Psychotropic Substances Act (PITNDPS) by the orders of Divisional Commissioner

In an official statement, Doda Police informed that Radhik Katoch S/o Mubarak Chand, R/o Khellani, Doda, a habitual drug peddler, who is involved in multiple cases of NDPS Act has been booked under (PITNDPS) for his active involve ment in illicit drug trafficking. The detention order has been ssued by the Divisional Commissioner, Jammu, and the accused has been lodged in District Jail, Bhaderwah.

The activities of the offender were found to be highly detrimental to society and a serious threat to public safety, partic ularly the youth. He has been involved in multiple cases regstered at different police stations of the district. Notably FIR No. 13/2020 U/S 8/20 NDPS Act, PS Assar, FIR No. 46/2025 under NDPS Act, PS Doda stand registered against him. Considering his repeated involvement in drug trafficking and continued criminal activities, his detention under PSA (PITNDPS) was deemed necessary to prevent him from further indulging in illegal narcotics trade. His detention is expected to act as a strong deterrent to drug smugglers and ave the youth from falling prey to drug abuse.
