AND WHEREAS, some of the incumbents who have obtained their PG degrees through distance/private mode during service and whose cases have not yet been recommended by the Designated Committees constituted vide Government Order No. 188-JK (Edu) of 2024, dated 15.03.2024, have also been included in the seniority list, subject to the condition that their cases are recommended by the said Designated Committees. In case recommendations are not received in their favour from the Designated Committees, their names shall be deemed to have been deleted from the seniority list ab-initio.
