and how to revive co-operative societies in a new way, besides the reservations, Abdullah said.

On December 10 last year, the government constituted a Cabinet sub-committee to look into grievances raised by various sections of aspirants against the existing reservation policy in the UT. The sub-committee forwarded its report in October, and accordingly, the report and its review by the law department were completed.

"It would be wrong to comment on the minutes of the Cabinet meeting before sending them to the honourable LG. I will just say that we have tried to rationalise it as we have promised. We have also tried not to be unjust to anyone," the chief minister said.

Abdullah also noted that so much time was taken because "the issue is such that t is very easy to do politics with it".

"The Cabinet has tried to adopt a transparent and fair process. Now, the matter will go to the LG. I will not say anything more until the file reaches him. Whatever you want to believe, you can believe it. We could not have done a more detailed exercise than this.

"Every issue was seen and discussed more than once. This is the third or fourth time that the matter came to the Cabinet after the sub-committee headed by Minister Sakina Itoo submitted its report. We did our best to resolve this matter, Abdullah said.

On the stance of the estranged National Conference Lok Sabha MP, Aga Syed Ruhullah Mehdi, on the reservation issue, the chief minister said the government did not do this for anyone's satisfaction.

"This is not about an individual. This is about the people of Jammu and Kashmir, and we have fulfilled another election promise by completing this process," he said. Abdullah added that the people, who were "taunting" the government, claiming it did not do anything about the reservation, are threatening protests if injustice is done to any section. Mehdi recently asked the National Conference-led government

In his address, the police chief sensitized about the constant adversarial tactics dopted by the neighbouring country to harm the security and harmony in India. In Jammu areas, he said police and security forces face unique challenges, includng drone droppings, tunnelling and riverine issues.

default on all phones and tablets. Defending its own app, the government said it was "secure and purely meant to help citizens from bad actors in the cyber world." The ministry added that the measure was no longer necessary as the app was gaining "wide user acceptance" on its own.

Earlier in the day, Communications Minister Jyotiraditya Scindia indicated that the government was willing to make changes in the November 28 order but insisted that the snooping is neither possible nor will it happen with the app.

Sanchar Saathi app "se na snooping sambhav hai, no snooping hoga", he said in response to Congress leader Deepender Singh Hooda's supplementary question in the Lok Sabha regarding snooping concerns related to the app.

Scindia had on Tuesday stated that users could delete the app, which becomes operational only when a user registers on it.

If a consumer has not been registered on the app, then the app will not be operational and one can also delete the app, he repeated in the Lok Sabha on

There have been around 1.5 crore app downloads already.

With the portal and the app, 26 lakh stolen handsets have been traced, 7 lakh stolen handsets have been returned to consumers, 41 lakh mobile connections have been disconnected and 6 lakh frauds have been blocked, the minister said.

In the November 28 order, his ministry directed smartphone makers to pre-install the app on all new devices and push it through updates on older ones

The order mentioned that the pre-installed app should be "readily visible and accessible" and "functionalities are not disabled or restricted".

tional version of the app and later claim compliance. Nowhere it has been mentioned in the above clause that the Sanchar Saathi App cannot be uninstalled by the end user. It is up to the citizen if he wants to enable and register Sanchar Saathi Mobile App or uninstall," it had said.

The explainer was issued prior to the withdrawal of the order.

Mann-Made Disaster. Chugh said the Centre, under Prime Minister Narendra Modi, released both installments of the SDRF Central share-Rs. 240.80 crore each-even ahead of schedule. This was accompanied by additional support for flood-affected farmers, including over Rs. 221 crore transferred directly to more than 11.09 lakh farmers under PM-KISAN, free wheat seed distribution worth Rs. 74 crore under PM-RKVY, and joint Centre-State assistance for Berseem seed distribution benefiting thousands of hectares, he said.

Chugh pointed out that allocations under the National Mission on Oilseeds and the horticulture mission were also made to help affected farmers rebuild their liveli-

Referring to the statement made in Parliament by the Union Minister of State for Home, which revealed that on April 1, 2025, the Punjab government had an opening balance of Rs. 11,947 crore in the SDRF. Chugh said it is now abundantly clear that the Mann government has misappropriated, diverted, and concealed the fund's utilisation. He said Punjabis deserve to know where the money went, and why the state government kept them in the dark.

Chugh said that despite having enormous funds in its disaster relief account and receiving continuous Central support, the Mann government chose to hide facts, distort data, and mislead Punjabis to whip up anti-Centre sentiment.

'When people needed relief, Punjab's money was locked up. Instead of using SDRF for immediate support, the AAP government spent its time building political narratives. This is criminal negligence," he said.

Chugh demanded a high-level investigation and said accountability must be fixed for this financial misconduct. "Punjab has reached a point of financial collapse. There is no development on the ground, and salaries are delayed for months. This is absolute administrative failure," he said.

He added that while the government spends crores on false publicity, advertisements, and image-building, it has done nothing for public welfare or infrastructure, leaving people frustrated and helpless. "The entire state exchequer today exists only to serve Bhagwant Mann's mentors sitting in Delhi," Chugh said. Citing recent media reports exposing the sharp decline in Punjab's capital expen-

diture, Chugh said the situation reflects a near-economic emergency. In the first half of the 2025-26 financial year, capital expenditure in Punjab fell by 36 percent, crashing to just Rs. 1,760 crore, with the government managing to spend only 17 percent of its own budgeted provision. "This government has failed on every front. Instead of governance, they are busy pleasing the Tihar Gang Trio and staging political drama," he said.

JAMMU: Ten drug peddlers were arrested with different quantities of heroin from various parts of Jammu region on Wednesday, police said.

Besides, a "notorious" drug peddler was detained under the Prevention of Illicit Traffic in Narcotics Drugs and Psychotropic Substances Act (PIT-NDPS Act) here

A private car was intercepted at PCP Nomain near Katra in Reasi district, lead ing to the arrest of four peddlers including two women and recovery of 11.22 grams heroin, a police spokesman said.

The accused were identified as Ajay Sharma, Vinay Singh, Sonia Dogra and Namita Dogra

In Udhampur district, Ishfaq Majid, Umar Shafiq and Mohsin Aslam Khan were arrested when police intercepted their car and recovered 53.44 grams of heroin at Tikri, the spokesman said, adding the trio were travelling from Jammu to Srinagar

A notorious drug peddler, Sonu Sharma alias "Jabbu" was arrested along with 5.43 grams of heroin from Bishnah area of Jammu, while two more drug peddlers Noshad and Mohd Irfan, were arrested from Thanamandi and Manjakote areas of Rajouri and 5.25 grams of heroin and 3.04 grams of heroin were recovered from them, respectively, the police said.

Dheeraj Choudhary, a resident of Kothey Chohala village of R S Pura, was booked under PIT-NDPS Act on the orders of Divisional Commissioner, Jammu, the spokesman said.

He said Choudhary, a notorious drug peddler, was lodged in the district jail a Poonch after his detention
