We want to give strength to swadeshi and Vande Mataram will be our mantra," the prime minister said. Modi said a look at the background of Vande Mataram and its stream of values,

reflected the recurring truth from the Vedic era. "Vande Mataram reminds us of the Vedic declaration meaning that this land is my

mother and I am her son," he said. The prime minister recalled that Mahatma Gandhi wrote in 1905 that Vande

Mataram has become so popular that it has emerged as national anthem and wondered why injustice was meted out to it. "If Vande Mataram was so popular, why was injustice meted out to it, why was it

petrayed in the last century. What were those forces that were so powerful to overrule the wishes of Mahatma Gandhi on Vande Mataram," he said.

Modi lamented that the Constitution was "throttled" and the nation chained by the Emergency when the national song Vande Mataram completed 100 years The prime minister also noted that Vande Mataram stood like a rock and inspired

unity despite British oppression. The prime minister noted that the mantra of the national song gave power and nspiration to the entire country during the freedom struggle.

"The mantra energised and inspired India's freedom movement and showed the

path of courage and determination.

Five cases against...

Police conducted routine checking and scrutiny of hotels, homestays and housepoats and found five establishments to be in violation of the rules under the Act. The action comes a day after a Chinese national was detained after he had allegedy entered the Union territories of Jammu and Kashmir and Ladakh in violation of his visa stipulations.

"In Rajbagh area, it was found that Hotel Blossoms, Hotel Grand MS, and Hotel Golden Forest had allowed foreign nationals to check in without submitting Form-C to the Foreigners Registration Office. Accordingly, a case under sections 8 and 23-B of the Immigration & Foreigners Act was registered," the spokesman said.

He said Hotel Khyber, in Khayam area, was also found violating the mandatory Form-C reporting. Despite repeated instructions, the management failed to produce any proof of Form-C submission, inviting a case under relevant sections

A case was registered against a homestay at Lal Bazar after it was found operatng without Form-C compliance for an Israel national. "The management had deliberately concealed the stay of the foreign guest and failed to submit mandatory online Form-C," he added. In Nishat area, house Mohammad Ashraf Zargar was found vioating the mandatory reporting of Form C, the spokesman said.

In Ram Munshi Bagh, cases were registered against four houseboat owners for failing to report foreigners from Taiwan, Spain, Russian and Romania, staying with them. "Srinagar Police reiterates that all hotels, guest houses, houseboats and homestay operators must strictly comply with Form-C submission norms when accommodating foreign nationals. Non-compliance of the same is a serious offence and will invite strict legal action," the official said.

The pleas were filed relying upon the May 2, 2024, order of the top court, in which it was directed that one-third of seats in the executive committee of the Supreme Court Bar Association, including one office-bearer post, be reserved for women.

Centre's opposes in SC Sonam Wangchuk's request to appear through video conferencing

NEW DELHI: The Centre on Monday opposed in the Supreme Court the request made by climate activist Sonam Wangchuk to appear through video conferencing from Jodhpur jail in the case related to his detention under the National Security Act. The top court was hearing a plea filed by Gitanjali J Angmo, wife of Wangchuk, alleging that his detention was illegal and an arbitrary exercise that violated his fundamental rights.

Senior advocate Kapil Sibal, appearing for Angmo, told a bench of Justices Aravind Kumar and N V Anjaria that the activist wanted to be connected via video from jail and sought permission from the bench. Solicitor General Tushar Mehta, appearing for the Centre, opposed the request, saving, "We will have to give the same treatment to all convicts across the country." The top court adjourned the matter for hearing on December 15. On November 24, the top court had deferred the matter after Solicitor General Tushar Mehta, appearing for the Centre and the UT of Ladakh, sought time to respond to the rejoinder filed by Angmo. On October 29, the top court sought responses from the Centre and the Ladakh administration on an amended plea of Angmo. Wangchuk was detained under the stringent National Security Act (NSA) on September 26, two days after violent protests demanding statehood and Sixth Schedule status for Ladakh left four people dead and 90 injured in the Union territory. The government had accused him of inciting the violence. The amended plea by Angmo contended that the detention order is founded upon "stale FIRs, vague imputations, and speculative assertions, lacks any live or proximate connection to the purported grounds of detention and is thus devoid of any legal or factual justification".
