The Deputy Commissioner, Ramban vide No. DC/R/JKLGGC /2021/1698 dated: 25-02-2021 has reported that the application for hypothecation deed of bike bearing registration No. JK19-5849 remained pending with effect from 05-03-2020 to 23-02-2021 in your office and same was issued by you on 23-02-2021 when it was known to you that the applicant has registered a complaint in the Lieutenant Governor's Grievance Cell.

The show cause notice to ARTO Ramban states "the applicant's file was disposed off after a gap of almost one year, which shows that there are sordid state affairs in your office".

"Now, therefore, in view of the facts elucidated above, you are directed to explain your position as why disciplinary action, as warranted under rules shall not be initiated against you for causing delay of almost one year in issuance of termination of hypothecation deed of bike bearing registration No. JK19-5849 in favour of Rajinder Singh in your office. This misconduct on your part as head of the office has caused not only mental agony and harassment to the applicant but also has severly dented the image of the department. The reply to this show cause notice should reach the office of Commissioner/Secretary (Transport) within seven days failing which it shall be presumed that you have nothing to say in your defence and action as warranted under law shall be taken against you", the show cause notice states.

Meanwhile, Pardeep Kumar, KAS, Transport Commissioner, J&K has been appointed as Inquiry Officer for conducting in depth Inquiry regarding the complaint and delay in redressal of the grievance of Rajinder Singh.

"He shall also enquire into the roles and responsibilities and conduct of the delinquent officers/officials and recommend the action to be taken against them, the order states, adding "the inquiry shall be completed and report shall be submitted within 15 days.

In written response to a question in Lok Sabha earlier this month, Union Minister of State for Home G Kishan Reddy said a total of 10,752 cases of ceasefire violations have taken place along India's border with Pakistan in the last three years, in which 72 security personnel and 70 civilians were

He said 364 security personnel and 341 civilians were injured in cross-border firings along the International Border and the Line of Control in Jammu and Kashmir in 2018, 2019 and 2020.

Asserting that the armed forces enjoy freedom on operational deployment, officials said the Indian Army remains committed to fight the scourge of terrorism.

"Acts of terror will not be tolerated and a befitting response would await any misadventure. Our counter infiltration grid continues to be strong. We will continue to undertake counter infiltration and counter terrorist operations. All options remain open to mitigate the threat as deemed by (our) commanders on ground," officials added.

With troops remain deployed along the Line of Actual Control in eastern Ladakh, the officials added that the situation along the northern borders has no bearing on the decisions along the LoC and the western front.

"The investigations conducted reveal that the accused had been in touch with ANEs (Anti-National Elements) and OGWs (Over Ground Workers), which includes some ac persons who are presently lodged in jail in NIA case.

Beyond streaming and messaging, the code will also set guidelines for digital publishers of news and current affairs content, requiring them to disclose their ownership and other information.

Releasing the guidelines. Prasad said the code was needed to make social media and OTT companies accountable for "mis-

Social media firms should be "more responsible and accountable." he said.

The new guidelines follow the government's spat with Twitter over allegedly inflammatory tweets and hashtags supporting farmer protests, with the microblogging service initially refusing to comply with orders to take down about 1,500 such posts and accounts. Twitter complied after it was threatened with the penal action.

Separately, an Amazon Prime Video original series 'Tandav' was ordered by authorities to be re-edited following protests over its depiction of Hindu gods and goddesses

Freedom-of-speech activists and technology trade groups had previously criticised the draft version of the new rules, which replace a previous code from 2011, saying they would result in increased censorship and reduced user privacy.

The new rules take effect immediately, though significant social-media providers (based on number of users) will get three months before they need to start complying.

Prasad said concerns have been raised over the rampant abuse of social media platforms and the spread of fake news.

"Social media companies are welcome to do business in India and empower Indians. We welcome criticism and dissent but it is important that users of social media are given a proper forum for the resolution of their grievances in a time-bound manner," he said.

India is a large market for digital and social media companies and is witnessing strong growth on the back of booming smartphone sales and the availability of dirt-cheap data.

The country has 53 crore WhatsApp users, 44.8 crore YouTube users, 41 crore Facebook users, 21 crore use Instagram and 1.75 crore are on Twitter.

Prasad said the rules require the 'significant' social media intermediaries to follow additional due diligence including the appointment of a chief compliance officer, a nodal contact person and a resident grievance officer. All three officials will have to reside in India. They will have to publish monthly compliance report and detail contents removed proactively.

The rules also state that users who voluntarily want to verify their accounts should be given an appropriate mechanism to do so and be accorded a visible mark of verification.

Users will have to be provided with a prior intimation and explanation when a significant social media intermediary removes content on its own. In such cases, users have to be provided an adequate and reasonable opportunity to dispute the action taken by the intermediary.

Rules related to social media will be administered by the Ministry of Electronics and IT, while those related to Code of Ethics and procedure and safeguards in relation to digital media will be administered by the Ministry of Information and Broadcasting. On rules related to over-the-top (OTT) and digital media, the government said, guidelines have been framed keeping in mind the difference between viewership in a theatre and television, as compared to watching it on the internet.

A Code of Ethics and three-tier grievance redressal mechanism would be applicable for news publishers, OTT platforms and digital media.

OTT platforms would have to self-classify the content into five age-based categories - U (Universal), U/A 7+ (years), U/A 13+, U/A 16+, and A (Adult).

Information and Broadcasting (I&B) Minister Prakash Javadekar said such platforms would be required to implement parental locks for content classified as U/A 13+ or higher, and reliable age-verification mechanisms for content clas-

The publishers of online curated content will also have to prominently display the classification rating specific to a programme together with a content descriptor, he added

Publishers of news on digital media would be required to observe Norms of Journalistic Conduct of the Press Council of India and the Programme Code under the Cable Television Networks Regulation Act, providing a level-playing field between the offline (print, TV) and digital media, an official statement said.

"Digital media portals have no right to spread rumour. The media's freedom is absolute but with reasonable restrictions. Content matter, especially media, OTT and digital media will be administered by I&B ministry. Intermediary platforms monitoring will be done by the IT ministry in the manner they have been doing it " he said

2,429 ASHAs appear... Theory Examination for Certification by NIOS.

The examination was conducted by NIOS in all the districts of the UT amid strict observance of COVID-19 protocols in the designated Centers in which 129 ASHAs appeared in Jammu district, 119 in Doda, 123 in Kathua, 116 in Kishtwar, 126 in Poonch, 178 in Rajouri, 116 in Ramban, 143 in Reasi, 129 in Samba, 123 in Udhampur, 125 in Anantnag, 141 in Bandipora, 152 in Baramulla, 129 in Budgam, 7 in Ganderbal, 120 in Kulgam, 121 in Kupwara, 180 in

Pulwama, 97 in Shopian and 55 appeared in Srinagar district. Pertinently, despite the COVID-19 pandemic J&K is at the topmost position among states and UTs where 20% of ASHAs appeared in the All India level NIOS examination held across the country today. Till date, 24.69% ASHAs of J&K have been certified by NIOS and the NIOS certification in J&K is likely to touch 41% which is proportionately the highest in the country. ASHA certification project is a Government of India initiative and third party accreditation for stabilizing level of quality in ASHA and their cadres as they deal with all the National Health Programmes for Pregnant ladies, vaccinations, communicable diseases, Tuberculosis, Leprosy etc. There is a tripartite arrangement between the Ministry of Health and Family Welfare (MoHFW), National Health Systems Resource Centre (NHSRC) and the National Institute of Open Schooling (NIOS) to undertake the process of accreditation of State and District trainers, State and

District training sites and certification for ASHAs. The certification of ASHAs has been envisaged to provide a legal and administrative framework within which the ASHA would be eligible and responsible for providing community level care for a range of illnesses. This would enhance the competency and professional credibility of ASHAs, allow her to use a set of drugs and point of care diagnostics appropriate to that level of care and also provide an assurance to the commu-

nity on the quality of services being provided by the ASHA. At present, about 13000 ASHAs have been engaged in the UT of J&K who shall be certified in a phased manner by NIOS in a period of two years. The department is targeting that 3000 ASHAs would appear in the All India Level ASHA Certification Examination in every six monthly session by National Institute of Open Schooling (NIOS) to create a pool of health activists in J&K. The focus is that after 2022, no ASHA is left uncertified in the Union Territory.
