

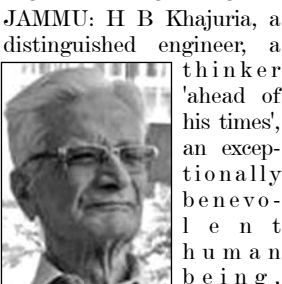

## H B Khajuria left mortal world, leaving a rich legacy behind

JAMMU: H B Khajuria, a distinguished engineer, a thinker 'ahead of his times', an exceptionally benevolent human being, who was popularly addressed as 'Bapuji' by his family, friends and admirers, left for his heavenly abode in morning hours on Tuesday, 8th February, 2022 after a brief illness, leaving behind a rich legacy of values and principles, that were an innate part of his being.

Still failing to come to terms with the loss, his elder brother, Mohinder Nath Khajuria, expressed his feelings, "My brother has gone from this world the same way he lived, helping and bringing smile to others. One could easily spot him in any social gathering, because of his positive energy and proactive engagement with those around him, motivating them to live beyond themselves, live for others. In his demise, I have lost my best friend."

Born on 20th October, 1935 to Late Khem Raj Khajuria and Late Smt Laj Wanti Khajuria in Jammu, H B Khajuria did his schooling from Govt. Shri Ranbir Higher Secondary School and pre-engineering from GGM Science College, Jammu. Then, he moved to Aligarh Muslim University for his degree in Civil engineering which he accomplished in 1957. After clearing prestigious J&K Public

Services Commission exam, he was posted as Assistant Engineer in Irrigation Division, Akhnoor. Projects in Irrigation Department and Public Health Engineering works being his forte, H B Khajuria pioneered and was entrusted with responsibility of commissioning of many important and vital projects including New Pratap Canal Akhnoor, Tawi Canal Irrigation Lift project, Ujh Barrage Ravi Tawi Irrigation complex to mention a few. He also formulated an ambitious drinking water scheme having intake from river Chenab consisting of multiple pumping stations to cater to needs for coming decades for Jammu City. This blue print is still being actively followed.


After superannuating from Public Health Engineering J&K as Chief Engineer, He took to his second calling of social service for helping poor & needy with an equal passion. He had also been active campaigner for Separate Jammu State under the banner of Jammu Mukti Moreha. No wonder, his post-retirement life was no less accomplished as he was bestowed with not one or two but three life-time achievement awards including one from Indian Institute of Engineers, second from Senior Citizens Society and third one from Balgran- a Charitable Home for Destitute Children, Channi Rama, Jammu.

A proud father of three talented daughters, who are well-settled and doing exceedingly well professionally in their lives, H B Khajuria was a strong propo-

nent of 'girl child education' as he used to say, "Social empowerment begins with girl education." H B Khajuria was such a forward thinker that he had even expressed his wish during his lifetime that his daughter should perform his last rites. Carrying forward the same

legacy, his youngest daughter Dr Aditi Khajuria performed last rites amid a sea of well-wishers representing all walks of life. "Losing a parent is like losing a part of yourself & while the grief will last forever but Bapuji, as we fondly called him, will remain in our hearts forever

and we pray to the Almighty to give us sanity and strength to live our lives in a manner that we always make him proud up above in the heaven," shared Dr Aditi Khajuria, echoing sentiments of all the near and dear ones gathered for her father's last journey.
