CRIME REPORT

Drug peddler booked under PSA in Kathua

KATHUA: An interstate drug peddler was arrested and booked under the stringent Public Safety Act (PSA) in Kathua district on Monday, police said. Rupesh Kumar alias Bobby is the first accused in a case of drug peddling to be arrested under PSA in Kathua this year and fifth since last year, a police spokesman said. He further said that Kumar, a native of Punjab's Gurdaspur and presently living in Kathua's Chak Drab Khan village, was evading arrest for over six months and was arrested by a special police team. In order to keep a check on his activities, the spokesman said, a dossier was prepared against him and sent to Divisional Commissioner Jammu for his detention under PSA some time back. Accordingly, the officer issued a detention warrant against him and it was executed on Monday, the spokesman said. Kumar has been lodged in Central Jail, Kot Bhalwal. Last year, Kathua Police had booked four drug peddlers under PSA as part of their drive against drug menace.

2 bootleggers arrested, illicit liquor recovered

BANDIPORA: Acting tough against social crimes, Police on Monday arrested two bootleggers and recovered 15 bottles of illicit liquor from their possession.

As per details, officers at a checkpoint established at Pazzalpora near forest Check Post intercepted a vehicle (JK01K-9517) with two persons onboard, who were identified as Reyaz Ahmad Ganie, resident of Ayatmulla and Javaid Ahmad Ahanger, resident of Bankoot. During search, 15 bottles of illicit liquor were recovered from their possession. They were arrested and shifted to Police Station where they remained in custody. The vehicle used in the commission of crime has also been seized. FIR No. 03/2022 under relevant sections of law has been registered at Police Station Pethkote and investigation started.

2 drug peddlers arrested; contraband recovered

SRINAGAR: Continuing its efforts to eradicate the menace of drugs from the society, Police on Monday arrested 2 drug peddlers in Anantnag & Srinagar besides recovering contraband substane from their possession.

As per details, Police Station Anantnag received a specific information through reliable sources that one Nawaz Ahmad Wani, son of Mohd Yousuf Wani, resident of Hakura has indulged in drug peddling and hoarded a large quantity of narcotic substances in his house. Accordingly, a Police party along with Executive Magistrate concerned raided the location and recovered 70 Kg Poppy straw. However, the accused managed to escape from the spot and efforts are on to arrest him.

Meanwhile in another action, a police party of Police Station Anantnag at a checkpoint established at Daggapora Khanabal intercepted a suspect who on seeing police party tried to flee but was apprehended taefully by alert cops. Identified as Rouf Ahmad Nanda, son of Abdul Hameed Nanda, resident of Daggapora Khanabal, 12 Kg of poppy straw was recovered from his possession. He was arrested and shifted to police station where he remained in custody.

In Srinagar, a police party from Police Station Rajbagh at a checkpoint established at Abdullah Bridge Srinagar and intercepted a suspicious person identified as Umar Sadiq Dar, son of Mohd Sadiq Dar, resident of Gopalpora Wathoora, Budgam. On checking, 250 strips & 6000 capsules of banned drugs were recovered from him. He

was arrested and shifted to Police Station where he remained in custody. Accordingly, cases under relevant sections of law have been registered in respective Police Stations and further investigation is going on.

Excise sleuths conduct raids in Rajouri; 160 Kg Lahan, 5 lts illicit liquor, working still destroyed

RAJOURI: Excise Department destroyed a working still along with 5 lts illicit liquor and 160 Kg of Lahan during different raids carried out to arrest menace of illicit distillation and sale of illicit liquor in Excise Range Rajouri-Poonch.

On the directions of Excise Commissioner, Kishore Singh Chib and supervision of Deputy Excise Commissioner (Executive) Jammu, Kusum Sharma, a team of Excise officials, led by Mohd Farooq raided Dalhori, Baregala, Argi, Dalhori, Kallar, Panda and adjoining areas of Rajouri to arrest menace of illicit distillation of liquor. During raids, 5 lts illicit liquor along with a working stills and 160 Kg Lahan was recovered and later destroyed on the spot.

15 bovines rescued; 3 accused arrested, fake permission documents recovered

JAMMU: In a massive drive against bovine smuggling, Police on Monday rescued 15 bovines including 11 from a vehicle (JK02AF/1739) and 4 from another vehicle (JK02AX/6629), during Naka checking at Ban Toll Plaza Nagrota. Fake permission documents were also recovered from driver of vehicle (JK02AX/6629) and both vehicles were seized.

As per the details, a team of Police Station Nagrota led by SHO Nagrota Insprv Vishav Pratap Singh while on Naka duty at Ban Toll Plaza rounded up a suspect namely Mohd Irfan, son of Idrees Ahmed, resident of Rammatra Tehsil & District Ramban with a vehicle (JK02AF/1739). During search, 11 bovines hidden under vegetables were recovered, which were rescued. FIR No. 39/2022 under sections 188 of IPC, 11 of PCA was registered at Police Station Nagrota and accused was arrested. Meanwhile, during Naka checking of another vehicle (JK02AX/6629) police team found a vehicle laden with 4 bovines. On questioning, driver namely Mushtaq Choudhary, son of Taj Din, resident of Sidhra and his associate Manzoor Ahmed, son of Gulzaar Ahmed, resident of Narwal Bala Jammu produced a permission letter by District Magistrate Office Jammu. On scrutiny, it was found that the signature on permission was fake and permission for the same number has already been issued. FIR No 35/2022 under sections 188/420/467/468/34 of IPC was registered at Police Station Nagrota and accused were arrested. The arrests and recoveries in both the cases were made by SHO Nagrota Insp Vishav Pratap Singh under the supervision of SDPO Nagrota Pardeep Kumar. The overall operation was done under the guidance of SP Rural Sanjay Sharma.
