

## STOP ACID ATTACKS

Of course the government holds responsibility of containing the acid attacks as the Supreme Court has shifted the responsibility of checking the sale of acid on local governments. The recent horrendous case of acid attack in Kashmir has exposed the delinquency of the concerned officials who were supposed to check the illegal sale of the acid because had the officials took the Supreme Court ruling in a tight perspective the victim in Kashmir would have leading a normal life. It is however good that the Jammu and Kashmir Government has agreed to bear the treatment expenses of 24-year-old acid attack victim and ensure her complete rehabilitation, even as the police would file a charge-sheet in the case in the next few days but what is disturbing is the fact that non-serious attitude of concerned officials has led to this precarious situation wherein the victim is struggling for life in a hospital in Chennai. The woman was hospitalized with burns after acid was thrown on her in Hawal area in Srinagar on February 1, this year. The case is a big lesson for the concerned officials because their non-seriousness has led to the difficult situation which has defamed the government in J&K and also put the entire family of the victim girl into deep trouble. The incident should be taken up as very seriously as the verdicts of Supreme Court came after churning the conditions of the concerned cases in the best possible manner. It is good that J&K administration has started a drive to check the sale of acid in the UT thus regulating the entire gamut but had these steps would have been taken earlier the present problem should have been avoided and the victim of the recent Kashmir acid attack had never faced the situation from which she is passing today. There is no doubt that the administration is duty-bound to provide for not only the treatment of the victim but her complete rehabilitation as well. It is promising that the doctors in Chennai have indicated a positive prognosis for the treatment. 'Better late than Never' phrase best suits the situation in the J&K UT because the market committees have started regulating the sale of the acid in the UT thus regulating the entire gamut but had these steps would have been taken earlier the present problem should have been avoided and the victim of the recent Kashmir acid attack had never faced the situation from which she is passing today. There is no doubt that the administration is duty-bound to provide for not only the treatment of the victim but her complete rehabilitation as well. It is promising that the doctors in Chennai have indicated a positive prognosis for the treatment. 'Better late than Never' phrase best suits the situation in the J&K UT because the market committees have started regulating the sale of the acid in the region.

## NECESSARY STEP

Looking into the unfortunate incident of stampede at the Cave Shrine of Mata Vaishno Devi on the wee hours of January 1, 2022, it has become necessary for the government to go for crowd management because the horrendous experience on the aforesaid day was an eye opener for the people as well as the dispensation sitting at the helm. No one in the country or even abroad had ever expected to have such an unfortunate incident taking place in the holy shrine of Maa Vaishno Devi because since times immemorial there was no incident similar to this one despite the huge rush of devotees thronging the Cave Shrine. Reportedly, to prevent untoward incidents at Shri Mata Vaishno Devi Shrine, a high-tech crowd management system has been approved by the government for the aforesaid shrine. Besides, the Government of Jammu and Kashmir has constituted a high-level committee to ascertain the reasons behind the stampede incident at Shri Mata Vaishno Devi Shrine. The Committee is headed by Principal Secretary (Home), Government of Jammu and Kashmir. As per reports, Shri Mata Vaishno Devi Shrine Board has taken the decision of online registration of pilgrims to the extent of 80 per cent of the total number allowed for Yatra. Token system and group system for releasing the pilgrims in Darshan queues in batches has already been put into practice. Besides, the Radio Frequency Identification (RFID) based crowd management system for live tracking of the pilgrims has been approved and soon the same will help in effective management of crowds all along the Yatra and at spots where there is rush conventionally. This initiative by the concerned quarters was a must looking into the tragic incident which took place on the very first day of the year 2022. As the government is proactive in carrying out initiatives to avoid any mishap in future the people visiting the shrine should also show the extreme level of maturity to avoid any kind of unfortunate incident in the future because had the people acted maturely on the day of tragedy many lives would have been saved and people will not have to pass through difficult times.

## Pandit Deendayal Upadhyay- a leader of masses

Pandit Deendayal Upadhyay was born on 25th of September 1916 at Nagla Chanderban village in Mathura District of Uttar Pradesh. He was fondly called Deena by his family members. Deendayal means 'One who has mercy for poor and is kind to the poor'. He had a very difficult and tough childhood as he lost his parents by the age of 7 years. He was brought up and educated at his maternal grandfather's home. Thus, deprived of love and affection of his parents in childhood, Pandit Deendayal gained strength from the negative forces and sufferings around him and developed a unique personality. He was a brilliant student during his school days and did his schooling from different places such as Gangapur, Kota, Raigarh, Sikar and Pilani. He was honored with a gold medal for securing first position in the board exam by the Maharaja Kalyan Singh of Sikar along with a monthly scholarship of Rs 10 and Rs 250 per month for books as recognition of his merit. Pandit Deendayal went to Pilani for intermediate where he obtained distinction in all the subjects and topped in board exam of 1937. Then, he joined Sanatan Dharma College Kanpur in 1939 and qualified BA in first Division. In 1939, he moved over to Agra and joined St John's college Agra to pursue a Masters Degree in English Literature but could not continue his studies and did not take up his exams due to some family and financial issues. Deendayal came to be known as Panditji for appearing in the Civil Services examination, wearing traditional Indian Dhoti-Kurta and cap. Again, at this exam, he topped the list of selectees.

Pandit Deendayal came into contact with Rashtriya Swayamsevak Sangh through his classmate Balaji Mahashbde. In 1942, he joined RSS as a full-time worker called 'Parcharak'. There, he met the founder of the party K B Hedgewar; underwent a 40-day camp in Sangh education, and a second-year training in RSS education wing. After this, he became a lifelong Parcharak of RSS, first for Lakhimpur district and then as a regional organiser of UP and was rewarded as an ideal Swayamsevak.

In 1949, Pandit Deendayal Upadhyaya started monthly 'Rashtra Dharm' paper from Lucknow in view of spreading the ideology of Hindutva nationalism. Later on, he also started weekly 'Panchjanya' and then daily 'Swadesh' from Kanpur. He wrote a

Hindi drama on Chandragupta Maurya, as biography of Shankracharya and translated Marathi biography of Hedgewar.

In 1951, Dr Shyam Prasad Mukherjee founded Bhartiya Jana Sangh. Pandit Deendayal Upadhyaya was rewarded to party by RSS, bestowed with the responsibility of moulding it into a genuine member of 'Sangh Parivar'. He was appointed as General Secretary of party's Uttar Pradesh branch and later as the All-India General Secretary. He remained General Secretary for 15 long years.

Pandit Deendayal Upadhyay's message was to build a strong and prosperous Indian nation on the foundation of Indian culture which guarantees freedom, equality and justice to all (Dharamayaya), maximum good to all i.e. benefit to the last man standing in a line.

He visualized a decentralized polity and self-reliant economy with village being the core, throughout India, as an independent nation cannot rely upon a Western concept like individualism to capitalism. In 1968, in the capacity of President of Jana Sangh, while addressing thousands of delegates in the Calicut session, a message was delivered through his speech that we are pledged to the service not of any particular community or section but of the entire nation. Every resident is blood of our blood and flesh of our flesh, we shall not rest till we are able to give to every one of them a sense of pride that they are children of 'Bharat Mata'. We shall make Mother India 'Sujala Suphala' (overflowing with water and laden with fruits) in real sense of these words. As Dashapraharerna Dharini Durga (Goddess Durga with her 10 weapons) she would be able to vanquish evils, as Lakshmi she would be able to disburse prosperity all over and as 'Saraswati' she would dispel, the gloom of ignorance and spread the radiance of knowledge all around her. With faith in ultimate victory let us dedicate ourselves to the task. On dark night of February 11, 1968, Pandit Deendayal Upadhyay was found dead at Mugal Sarai Railway yard. This day is observed as 'Samarpant Diwas'. The country soon realized Pandit Deendayal Upadhyaya's vision of building a self-reliant India. In 1965, during Indo-Pak War, India had to depend on foreign countries for weapons. Pandit Deendayal Upadhyay had said at that time that we need to build an India that is self-reliant not just in agriculture, but also in defense and weaponry.

## Zero tolerance towards corruption

The fight against the corruption needs strong will power and determination and we are fortunate enough

In this way we will be in a position to enforce discipline in the public institutions and also to fight the corruption. On one hand government should enforce discipline and punish the corrupt officers and on the other hand the honest officers and officials should be encouraged to work with selflessness and honesty so that the corruption is shown the door. There is need to award the honest officers on the eve of the national festivals so that they will continue to work with honesty and dedication. Thus the honest officials should be awarded with prizes and certificates on independence day and on the eve of republic day so that the honest officers are encouraged to work with honesty so that others will emulate their conduct and behavior and the corrupt need to be given stringent punishment so that others will not dare to indulge into dishonest and male practices and such punishments will work as a deterrent to corruption. The fact is that the corruption is today not on a small scale but has become a mass activity encompassing all fields of our public life and our administrative setup is fed up with the problem of corruption and it needs immediate attention. We have to purge the public life and institutions from the bane of corruption. The scam after scam has invaded our political and administrative system one outnumbering the other in severity and magnitude and these scams has become a common affair and have tarnished our image in the international community. In some cases ministers and other higher-ups are found involved into corruption and scams and some are facing the punishments as well and it is a good sign that the highest in the political hierarchy are facing the punishments and some are jailed like former Chief Minister of Bihar, Lalu Prasad Yadav. This will in fact serve as a deterrent to indulge in corruption. Anyway the declaration of zero tolerance to corruption by BJP Government of Modi is a matter of some satisfaction and all the responsible citizens should contribute their might in the fight against corruption so that the country will succeed in the fight against the corruption and get rid from bane of corruption at the earliest. Therefore all of us should actively help government in its fight against corruption and then only will we succeed in fighting the corruption from public life and polities.
