been categorised 'micro'. Weighing between 2 kilograms and 25 kilograms would categorise the unmanned aircraft system under 'small' category and the rest weighing between 25 kilograms and 150 kilograms fall under 'medium' category.

The Rules provide for creation of an interactive airspace map with Red, Yellow & Green Zones on the digital sky platform by the Central Govt. Whereas, prior permission from concerned ATC Authority is required for operating a UAV in Yellow Zone and only the Central Govt can allow for unmanned aircraft system operations in Red Zone. Drones can be operated in the Green Zones with upto 200 feet in an area between lateral distance of 08 to 12 kms from the perimeter of an Airport.

The circular further reads that before any unmanned aircraft system operation, a remote pilot has to mandatorily verify the digital sky platform for any notification or restriction applicable in the intended area of operation.

The Motor Vehicle Act, 1988 and rules would apply mutatis mutandis to the third party insurance of such an aircraft system . *The Drone Rules also provide for penalties for its violation which would be considered cognisable and non compoundable offence under CrPC. Any person who contravenes or fails to comply for the provision of the Rules shall be liable to be penalised under section 10A of the Aircraft Act, 1934, the order further reads.

The Div Com has impressed upon all intended operators of unmanned aircraft systems to strictly ensure the compliance of the Drone Rules. The details of the same need to be shared with the office of the concerned District Magistrate & nearest Police Station.

Dr Langer further said that there have been instances in the past, when 'enemy drones' have posed a threat to the national security and it is therefore imperative for all to observe the code in order to ensure safety and security of the vital installations like airports, international border/LoC, army installations etc.

delivery. All the services will be delivered through State Data Centre (SDC) and all the existing services will also be shifted on the SDC to ensure coherence and seamless integration, he added.

The chief secretary also directed that the services may be delivered in three languages i.e., English, Hindi and Urdu with Voice-to-Text conversion and document extraction facilities.

COVID: 547 new...

has recorded 226 Covid-related deaths -- 167 in Leh and 59 in Kargil, they said. No death was reported on Wednesday, officials said.

As many as 163 patients -- 98 in Leh and 65 in Kargil -- were cured and discharged from hospitals, taking the overall recoveries to 26,226, they said.

Of the new cases, 63 were from Leh and 23 from Kargil district, officials said.

A total of 1,244 sample reports were found negative in Ladakh, they said.

Disobeying orders of...

satisfactory and in terms of Rule 33 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956, Shafkat Ali Watali, IPS, the then Inspector General of Police, Armed/ IRP, Kashmir was appointed as an Inquiry Officer to conduct an inquiry into the charges framed against the delinquent officer," the order stated and added, "The Inquiry officer submitted his report to the Home Department, vide communication No. ZAPHQ/CS/DE-78/2018/18-17462 dated October 17, 2018."

In his report, the order stated, the Inquiry officer concluded that there is no direct/solid evidence, which could establish that Bashir Ahmad had refused to perform duties during his deployment as Zonal Officer, as such, not violated section 24 of the Police Act, 1983 and that keeping in consideration the facts emerged during the course of inquiry, the charges framed against Bashir Ahmad have not been proved/substantiated.

"The report of the inquiry officer was examined, with reference to the facts of the case, evidence brought on record and the conclusions drawn by the Inquiry Officer and it was observed that though the inquiry officer, in view of the ameliorating circumstances, including the officers personal experience, has not found direct evidence against the delinquent officer, the outright refusal by an officer of the rank of DySP to perform legitimate duties and disobeying orders of a senior police officer has the potential to affect the discipline in a belt force, which cannot be overlooked. The matter was, accordingly, placed before the Competent Authority alongwith all the material for a decision." the order stated.

The competent authority, the order stated, while conveying its decision to accept the findings of the inquiry officer and to close the inquiry against Bashir Ahamd Teeli has directed to issue a "Warning" to the delinquent officer to remain careful in discharge of official duty.

"Now, therefore, the report submitted by the inquiry officer in pursuance of Government Order No.659-Home of 2018 dated May 28, 2018, is accepted and the inquiry ordered against Bashir Ahmad Teeli is hereby closed with a "Warning" to the delinquent officer to remain careful in future in discharge of official duty," it added.

Innovation and incubation would be fostered in a hub and spoke model and expert assistance and guidance would be provided by the universities and other premier institutes such as the IIT-Jammu, IIM-Jammu and others. Earlier, the Principal Secretary reviewed the physical and financial expenditures under Capex for the current financial year of the various degree colleges. 17 bovines rescued, two vehicles seized

JAMMU: In a massive drive against bovine smuggling, Jammu Police has rescued 12 bovines from a vehicle at Naka in Manwal and seized a vehicle (JK03E 2502). In this regard, case under relevant sections was registered at Police Station Jhajjar Kotli and investigation started. The recoveries were made by SHO Jhajjar Kotli Inspr Devinder Singh assisted by Incharge Police Post Manwal PSI Ayub Khan under supervision of SDPO Nagrota Pardeep Kumar. Further investigation of case is going on. Meanwhile, a police team led by PSI Swaran Singh Manhas Incharge Police Post Marheen under supervision of SDPO Border Sachit Mahajan, while on Naka/checking duty near Banyari Bridge, noticed a suspicious vehicle (Mahindra Load Carrier) without any registration number and signaled it to stop for checking. Sensing danger, driver of the vehicle managed to flee from the spot leaving behind the vehicle. On thorough checking, Police team recovered 5 bovines, which were rescued. Thereafter, all 5 bovines were rescued and seized the vehicle. Accordingly, FIR No. 20/2022 under Section 188 of IPC and 11 of PCA act was registered at Police Station Rajbagh and further investigation started.
