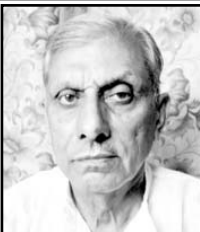

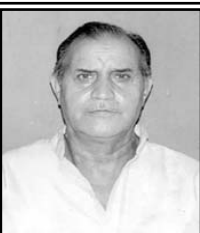

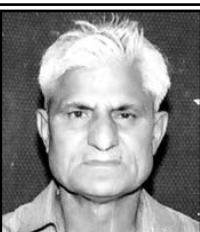

CRIME REPORT

Drug peddler arrested with Charas

KISHTWAR: Police on Friday arrested a drug peddler at Danrashi Tandar area of Dachhan and recovered Charas from his possession.

The accused was immediately taken into custody and arrested, who was identified as Ashiq Hussain, son of Ghulam Hassan, resident of Thachna Daehhan. FIR No. 06/2022 under relevant sections of NDPS Act was registered at Police Station Daehhan.
