DATED: 09- 02 - 2022

In view of communication of Joint Chief Electoral Officer, UT of J&K, Jammu bearing No. CEO-ElecCOGF/1/2022 dated 09-02-2022 "Dry Days" are hereby declared within 3 Kms radius of areas in Union Territory of Jammu & Kashmir which are adjoining the Assembly Constituencies in the State of Punjab w.e.f. 18-02-2022 (6:00 p.m.) to 20-02-2022 (6:00 p.m.) and on the date of counting i.e. 10-03-2022 in view of the General Elections to Punjab Vidhan Sabha 2022. All the liquor vend/trades/outlets selling liquor on/off the premises operating in these areas in the UT of J&K shall remain closed on the said dates.

Besides, any permit to serve liquor on Social Occasions at private places, Banquet Halls, Party Halls and Restaurant etc. issued by competent authority prior to the issuance of this order, within 3 Kms of the areas adjoining the State of Punjab in the Union Territory of Jammu & Kashmir corresponding the above dry days are also cancelled.

The officers and field staff of the Excise Department shall lay Nakas to prevent inter-state smuggling of liquor, if any, to the State of Punjab on the above mentioned days.

All the Controlling Officers shall get the instructions noted by all the concerned for strict compliance. The field staff and officers of the Excise Department shall ensure that there is no violation of the order.

The Excise & Taxation Officer, Excise Range, Kathua is designated as Nodal Officer who shall be the overall incharge of observance of dry days and laying Nakas on the aforesaid dates.

a. The Concerned students/schools shall visit the BoSE website www.jkbose.nic.in and the URL will open for filling the RR Forms of Class 9th Students. The Complete instructions have been given in BoSE website www.jkbose.nic.in.
b. The concerned Heads of the Affiliated Academic Institutions shall facilitate and guide the students and ensure that every student of their school correctly enters the data particulars online.
c. Disabled candidates having disability of **50% (Fifty percent or more)** are exempted from paying Registration Return Fee. However, they shall take a printout of the Registration Return Form submitted online, get it attested by the Head of the Concerned Academic Institution and submit the same in the concerned District/ Tehsil Office of the BoSE along with Disability Certificate from the concerned Medical Board.
d. Only those on-roll students of Class 9th for the Academic Session 2021-23, SZ, JD are eligible for submission of the Registration Returns **who shall attain the age of (14) Fourteen plus on the first day of May, 2023.**
e. The concerned Heads of the Affiliated Academic Institutions shall verify and ensure that all the particulars filled-in by the candidates are genuine and strictly in accordance with the Admission Records before forwarding these (online) to the JKBoSE.
f. Only those Academic Institutions who are affiliated with BoSE and in whose favour the facilities for the current Academic Session 2021-23 have been released by the General Section shall be able to transmit the Registration Returns of their on-roll eligible students.
g. The Academic Institutions to note that there shall be no checklists for this online registration process. The checklists in this regard can be downloaded from their respective Id's.
h. **The head of all the concerned institutions shall ensure that the candidate/s who is/are already registered with JKBoSE, shall not be re-registered, deviation if any in this regard will invite strict action against the erring Institute.**
