



CRIME REPORT

Woman among three absconders evading arrest since long arrested

JAMMU/RAJOURI: Police on Saturday arrested two absconders who were evading arrest since 6 years.
As per details, an information was received at Police Post Parade regarding two absconders who were evading arrest in FIR No. 64/2010 registered under section 188 of RPC but were absconding since December 31, 2016. On this, a special team under the supervision of SDPO North Sharad Kalu was constituted. The team led by Incharge Police Post Parade PSI Lalit Sharma with strenuous efforts and help of CCTV footages of area, arrested the absconders namely Mohd Sain, son of Kalam Din, resident of Hadoek, Ramban and Mussa, son of Shatu Din, resident of Hadoek, Ramban. Absconders were immediately handed-over to Police Station Kanachak for completing legal formalities. Meanwhile, Rajouri Police also nabbed an absconder who was wanted in a case registered fifteen years back. A team from Kalakot Police Station led by SHO Deepak Pathania intercepted an absconder and arrested him. He was identified as Rekha Devi, wife of Parlhad Singh, resident of Bhatara, Kalakote who was wanted in FIR No 32/2006 under sections 353, 332, 148 of RPC

but was evading arrest. Court had also issue an arrest warrant against her in 2014.

Thieves' gang busted; 2 arrested, 6 stolen vehicles recovered

JAMMU: Police on Saturday busted a gang of thieves by recovering 6 stolen vehicles and arrested two persons.As per details, several complaints were lodged at Police Post Bathindi regarding vehicle-thefts including complaint lodged by Ankush Bhagat, son of Sukdev Raj, resident of Parmandal Samba regarding theft of a motorcycle (JK02CF- 8427) and complaint lodged by a woman namely Shaheen Akhtar, wife of Karnat Hussian, resident of Dougian regarding theft of her scooty (JK11 E 6572) from different locations. On this, FIR No 238/21 under sections 457/380 of IPC and FIR No. 41/22 under sections 379 of IPC were registered at Police Station Bahu Fort and investigation started.
A team of Police Post Bathindi under the supervision of SDPO East Syed Zaheer Abbas Jafari led by SHO Bahu Fort Insp Nayat Ali assisted by Incharge Police Post Bathindi PSI Mohd Ilyas, with help of CCTV footages of area and other technical aids, along with timely human intervention, rounded up two suspects namely Tofal Hussian, son of Mohammad Sharief, resident of Ganjote, Mahore and Saquib Nazir, son of Nazir Ahmed, resident of Malvath, Ramban. During sustained questioning, accused confessed their involvement in crime and on their disclosure 6 stolen vehicles were recovered. The overall operation was done under supervision of SP City South Deepak Digra. Further investigation of the case is going on to ascertain their involvement in any other case.

Two drug peddlers arrested with Charas

DODA: Police on Saturday nabbed two drug peddlers and recovered 70 gm Charas

from their possession.
SSP Doda Abdul Qayoom said that under operation Sanjeevani, a party of Police Post Prem Nagar while conducting routine checking/frisking at the Naka Point on NH-244 near Prem Nagar, noticed a suspect, who was intercepted by Naka personnel and during checking/frisking, 30 gm Cannabis (Charas) was recovered from his possession. On enquiry, he disclosed his identity as Jugal Kishore, son of Om Prakash, resident of Iderralla, Thathri. He was arrested and FIR No 22/2022 under sections 8/20 of NDPS Act was registered against him at Police Station Thathri. The recovery was made under supervision SHO Thathri Insp Amrit Katoch and Abdul Ghafoor SDPO Bhadarwah.
Meanwhile, a police party led by SI Bupinder Singh Incharge Police Post Bhalra during routine Naka checking at Drudu Bridge intercepted a vehicle (JK 06A/0383) and on frisking of driver, police recovered 40 gm cannabis (Charas) from his possession, who was identified as Ravi Baloria, son of Kashmir Singh, resident of Dranga, Bhadarwah. He was arrested and FIR No. 18/2022 under sections 8/20 of NDPS Act was registered against him at Police Station Bhadarwah. The recovery was made under supervision of SHO Police Station Bhadarwah Jatiner Singh Rakwal and Meer Ghafoor, SDPO Bhadarwah.
