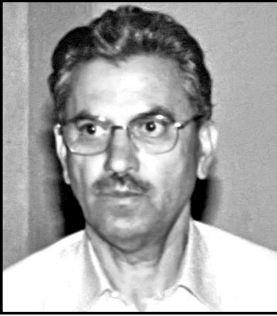

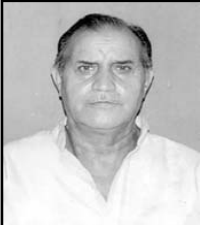

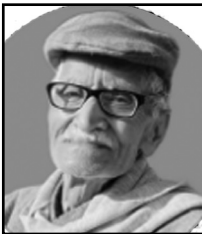

CRIME REPORT

21 bovines rescued, smugglers escape

RAJOURI/KATHUA: Police on Monday rescued 21 bovines in twin bids of smuggling, however smugglers managed to escape from spot.

As per details, a team of Dharamsal police station under supervision of SHO Neeraj Choudhary intercepted a Tata mobile (JK11E 7986), which was found laden with 8 bovines. The driver of vehicle escaped from the spot soon after observing police Naka. On this, FIR number 12/2022 under section 188 of IPC 11 of PCA act has been registered.

Meanwhile Lakhampur police also rescued 13 bovines from a vehicle during Naka, however smuggler managed to escape from the spot.

Woman found hanging

Thief arrested for stealing bag from Bhawan

KATRA: Police on Monday arrested a thief for stealing a bag of a pilgrim from Vaishno Devi Bhawan area.

As per details, a pilgrim namely Kavita Yadav, daughter of Balram Yadav, resident of Delhi lodged an online complaint with police that on February 9, when she along with her friends visited Bhawan to pay obeisance at Shrine, somebody stole her bag containing mobile and other documents.

Acting on it, Bhawan police under the supervision of SDPO Bhawan Nikhli Rasgotra raided a suspected location and nabbed an accused, identified as Shashi Kumar, son of Bhushan Lal, resident of Katra.

On his disclosure, police also recovered the bag. On further investigation, accused also disclosed his involvement in many other theft cases after which 22 mobile phones worth Rs 4,26,000 were also recovered.
