individual can save upto three lives besides stimulating blood cell production", Mahesh said.

He added that donating blood reduces harmful iron stores, lowers the risk of suffering

Apart from officers and officials of DoP, around 40 volunteers of the department donated blood during the camp and took pledge to make it a routine exercise as their support towards society as a concerned citizen.
