REASI: With the aim to improve investigation skills in the cases under NDPS Act, Reasi Police organised one day workshop on cases under NDPS Act for investigating officers of district police Reasi.

In the workshop besides ASP, SDPOs, SHOs investigating officers- Sub Inspectors, Probationary Sub Inspectors, Assistant Sub-Inspector of district police Reasi Participated.

The team of officers of Anti-Narcotics Task Force (ANTF) of Crime wing, a premier investigating agency of J&K police with rich experience of busting networks of drug

peddlers & booking them under law delivered a lecture. Going into threadbare details on Investigation under NDPS Act and destruction of illegal crops.

Team of ANTF delivered lecture with special emphasis on role of Smugglers and Foreign Exchange Manipulators (SAFEEMA) in forfeiture of Property collected as proceeds of drugs. A brain storming session of officers deliberated on common procedural omissions during investigation while seizing the banned drugs & collecting related evidences under NDPS Act as well as 'benefits of doubts' being drawn

by accused persons.

Officers from ANTF spoke on relevant sections of NDPS Act and role of investigating officers in doubts-free collection of evidences by following the laid down procedure under Code of Criminal Procedure (CrPC). Team also shared their experiences through case studies and judgments on the Act with the Participants.

Shailender Singh Senior Superintendent of Police Reasi who remained present during the session Conveyed that aim behind this course is to upgrade investigating skills. Investigating officers of police are important component of justice delivery system in the country & it is must to strengthen them by empowering with improved knowledge & skills. He said that target is to achieve highest standards of investigation which is prerequisite for improving conviction rate. District Police Reasi is executing the plan of upgrading the police on all fronts including investigation and law and order, for this courses and refreshers are being organized at regular intervals. Singh thanked team of ANTF for sparing their valuable time for guiding the investigators of district police Reasi.

After the Department of Disaster Management, Relief, Rehabilitation and Reconstruction/s issued an order that all the schools in Kashmir valley and those which fall under the winter zone of Jammu Province will be opened for physical classes

from 28th February, Government school authorities in collaboration with Municipal Committee Bhadarwah and started sanitization spray and fogging of classrooms, laboratories, libraries and playgrounds beside painting and white wash of the buildings.

The sanitization and safe environment drive which will be carried and completed in all the schools of Bhadarwah town and it's peripheral areas before 28th February, started on war footing from Govt boys higher secondary school Bhadarwah under the supervision of Executive officers

Municipal Committee Bhadarwah Yousaf-ul-Umar.

The drive is aimed at to provide students a secure environment for physical classes and to ensure implementation of Covid appropriate behavior in the schools when these will be reopened after a gap of 2 years. All the educational institutions in entire Jammu and Kashmir were closed after the Covid outbreak in March 2020. While colleges and universities partially resumed classes last year, schools were not allowed to open due to the second Covid wave. The orders to reopen all schools was issued by the J&K state disaster management committee after reviewing Covid situation in the region.

"It's a huge relief. I just can't believe schools will opening in Kashmir and our children will back in classes", said Arif Rana a parent and a teacher by profession.
