

**MISSING CHILD RECOVERED FROM MAHARASHTRA****STATE TIMES NEWS**

BUDGAM: Police on Wednesday arrested one more person and seized 2 more vehicles in connection with FIR number 28/2022 pertaining to busting of an Inter-district gang of vehicle-lifters. Earlier, 4 accused were arrested & 13 stolen vehicles were recovered in instant case.

During course of investigation, two stolen vehicles with fabricated registration numbers were recovered from Waterhail area of Budgam, taking toll of recovered stolen vehicles to 15. The recovered vehicles included White coloured Alto K10 bearing registration number JK08F-6559 and Granite Grey coloured Baleno bearing registration number DL7CQ-8839. Moreover, one more accused identified as Shabir Ahmad Rather, son of Ab Karim Rather, resident of Waterhail, Budgam was arrested and shifted to police station where he remained in custody. The investigation of case is still going on and more arrests and recoveries are expected.

3 drug peddlers arrested, psychotropic substances recovered**STATE TIMES NEWS**

SRINAGAR: Continuing efforts to eradicate menace of drugs from society, police arrested three drug peddlers in Ganderbal & Sopore and recovered psychotropic substances from their possession. As per details, officers from Police Post Shadipora at a checkpoint established near Shadipora Bridge intercepted two suspects, identified as Mohd Yaseen Ganai, son of Bashir Ahmad Ganai and Mohd Younis Ganai, son of Mohd Rafiq Ganai, both residents of Arampora, Sumbal. During checking 24 bottles of Codeine Phosphate were recovered from his possession.

Similarly in Sopore, officers from Police Post Watergum under supervision of SDPO Rafiabadi at a checkpoint established at Ladoora crossing intercepted one Bilal Ahmad Ganai, son of Munawar Ahmad Ganai, resident of Ladoora, Rafiabadi. During checking, 1,520 capsules of Spasmoproxyvon tablets were recovered from his possession. All accused were arrested and shifted to respective police stations where they remained in custody. Accordingly, FIRs under relevant sections of law were registered and investigation started.




