

**SHRADHANJALI**


**S**mt Dershi, daughter of Late Shri Gubax Lal was born on July 3, 1945 at Pathankot. She had 2 brothers and a sister.



**BARI BRAHMANA:** Samba on Saturday traced a minor missing girl and reunited her with parents. As per details, on February 23, 2022, a complaint was lodged at Police Station Bari Brahma by mother of missing girl, a resident of Dhansar, Bari Brahma stating therein that her daughter went missing from her residence. **JAMMU:** Police on Saturday arrested two narco smugglers and recovered 20 gm heroin from them.
