RAMBAN: As per District Immunization Officer, Ramban, Dr. Suresh, the Health Department on Sunday administered Covid vaccine doses to 29 persons, including 11 children in the 15-17 years age group in the district. Continuing the enforcement of Covid SOPs, the Enforcement teams fined scores of violators for roaming without wearing face masks and not maintaining physical distance.

The enforcement teams, during the inspection in their respective jurisdictions, recovered a fine of Rs. 21,800 taking the total amount fined since April 1, 2021 to Rs. 94, 95, 450. The Enforcement officers urged the people to wear face masks and maintain physical distance besides taking Covid vaccination doses at their nearest CVC.

As per daily bulletin issued by the Chief Medical Officer, Ramban, Dr. Mohammad Fareed Bhat, the Health Department has collected 2682 samples including 548 RT-PCR and 2134 RAT samples besides administering Covid vaccine to 29 persons at various dedicated Vaccination Centres in the district.

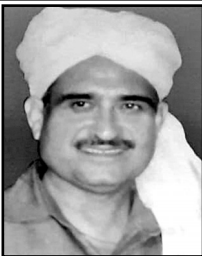

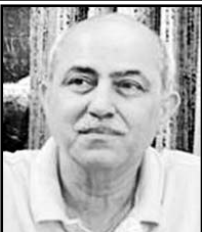
