

8.66 lakh children provided pulse polio drops in Jammu Div

JAMMU: Divisional Commissioner Jammu, Dr Raghav Langer on Sunday launched the National Polio Immunization 2022 drive by administering polio drops to children below five years of age in the Rajiv Gandhi Hospital Gangval Jammu in the presence of Director General Family Welfare MCH & Immunization J&K, Dr Saleem Ur Rehman who is also holding the charge of Director Health Services Jammu.

Dr Raghav Langer said, "Elimination of polio cases in J&K is the success of Health care workers and other government agencies engaged in this noble cause. It is a success story of Public Health policy against vaccine preventable diseases.

We need to continue to be vigilant and ensure that every child below 5 Year of age must get polio drops."

Later, the Divisional Commissioner also took a round of the premises of the Rajiv Gandhi Hospital.

Dr Saleem Ur Rehman along with Medical Superintendent

Dr Sanjay Sharma briefed him about the upgraded patient care in the hospital.

The Divisional Commissioner Jammu expressed satisfaction over the functioning of the hospital. He called for upgrading of infrastructure and deployment of trained manpower in far flung areas of Chenab Valley

Region.

Dr. Raghav Langer appreciated the working of the department and expressed his gratitude towards the dedicated health workers who fought a successful battle against Covid Pandemic and many of them lost their lives.

In the Jammu Division, 866773 children up to the age of 5 years will be administered 2 drops of polio vaccine during this intensified pulse polio drive.

On the 1st day, 5488 booths were established aided with 10247 teams and 21259 health care workers for the same. Also, 127 transit points have been established with 474 team members to cover children during the travel, 1107 supervisors will be observing the drive in the entire Jammu region. On the

second and third day Health care workers will also visit House to House to cover any left out children.

Although Polio has been eradicated from India but due to high prevalence of the same in the neighbouring countries it is essential to maintain a vigil.

To stop polio from reentering into the country, the Government of India in collaboration with state governments conducts this drive year after year.

Assistant Director Family Welfare MCH & Immunization Jammu Dr Suman Gupta, Dr Shahid Hussain Immunization Officer J&K, Deputy CMO Jammu, District Immunization Officer Jammu along with others also remained present during the launch.

IPPI drive held across Kashmir, about 11 lakh children vaccinated

SRINAGAR: The Divisional Commissioner Kashmir Pandurang K Pole on Sunday inaugurated Intensified Pulse Polio Immunization (IPPI) programme for the children of 0-5 years age at JLNH Hospital, Rainawari, Srinagar by administering Polio drops to newborn infant, here.

Director Health Services Kashmir, Dr Mushtaq Ahmad Rather; MS, JLNH Hospital and medical and Paramedical staff of the hospital were present on the occasion.

Speaking on the occasion, Div Com said that about 11 lakh children will be administered Polio drops across Kashmir Division at 5391 Polio booths to eliminate the disease and protect children.

He said that 22059 vaccinators have been put on the duty to cover all the eligible population of children in Kashmir division. Besides, he said 298 transit teams and 143 mobile teams have been constituted to make the immunization drive successful. Meanwhile, he appealed to parents to take their children to the near by booths, health center or hospital for Pulse Polio drops and save their children from the disease.

Deputy Commissioner Budgam, Shahbaz Ahmed Mirza inaugurated the first phase of pulse polio programme at Chief Medical Officer's Office, Budgam by administering Polio drops to children up to 5 years of age.

Chief Medical Officer, Budgam Dr Tajamul Hussain Khan, Dy. Chief Medical Officer Budgam, Dr Tehmeena Bukhari, D/O, DIO, DPMU and other staff were also present on the occasion.

DC deliberated upon the

importance of administering polio drops to children up to 5 years to save them from polio throughout their life.

He urged parents to take their children to the nearby health booths to ensure their children remain safe and healthy. After launching the drive Dy. Chief Medical Officer Budgam Dr. Tehmeena Bukhari said that as many as 121261 children up to 0-5 year's age group are being covered under Pulse Polio Immunization Programme in District Budgam.

At Kupwara, Deputy Commissioner Kupwara, Imam Din inaugurated Intensified Pulse Polio Immunization (IPPI) drive by administering anti Polio drops to an infant, here at Sub District Hospital Kupwara in presence of Chief Medical Officer Kupwara, Block Medical Officer and DIO.

On the occasion, the Deputy Commissioner was informed that 140017 children below 5 years of age will get immunized under Pulse Polio programme in the district.

It was also informed that 738 Immunization booths have been established across the district for which 2952 workers including 970 ASHA and 640 AWW have been deployed to carry out the immunization programme smoothly.

Speaking at the occasion, the Deputy Commissioner said that special teams have been deputed to far flung and border areas like Keran, Machill and Karnah to ensure complete immunization of the children. He stressed upon the concerned officers to ensure cent percent coverage of the target population of the children below the 5 year age group under the Pulse Polio programme.

At Pulwama, the Pulse Polio immunization campaign was launched by the Deputy Commissioner Pulwama Baseer Ul Haq Choudhary at CMO office Pulwama where he administered polio drops to the children. Chief Medical Officer, Dy CMO, District Immunization Officer, Nodal Officer RBSK, Doctors and Paramedical staff were also present on the occasion. After launching the drive, DC said that 89228 children of 0-5 years are to be administered Pulse Polio drop in district Pulwama for which 1966 personal of health department & Supervisors have been deployed at 468 Pulse Polio centres. He said the Government has initiated various measures for better health facilities of the children's across the state.

At Ganderbal, Additional District Development Commissioner Ganderbal, Khurshid Ahmad Shah kick started the campaign for Intensive Pulse Polio Immunization here at District Hospital Ganderbal.

He started the campaign by administering oral anti-polio vaccine drops to the children in presence of the CMO, Dr. Afroza Shah, DyCMO, Dr. Nighat Yasmeen and MS DH Dr. Yasmeen Kangoo.

It was informed that 48781 children upto age of five years will be vaccinated during the Intensified Pulse Polio Immunization programme in the district to protect them from the disease.

The CMO informed that 237 vaccination booths have been established in all medical blocks with adequate deployment of officials of various departments including Anganwadi workers, Ashas and Supervisory staff

besides 04 transit points have been also established for smooth and hassle free vaccination in the district.

The ADDC directed the officers of the health department to ensure 100 percent coverage of the immunization programme and also asked for door-to-door survey particularly in remote and high-risk areas to leave no child uncovered under the campaign in the district.

At Shopian, DDC, Chairperson Bilqees Jan along with the Deputy Commissioner Shopian, Sachin Kumar vaishya, SSP Shopian inaugurated Intensive Pulse Polio Immunization programme, at District Hospital Shopian where the DDC Chairperson and Deputy Commissioner started the campaign by administering oral anti-polio vaccine drops to new born infants in presence of CMO, Superintendent, Dy. CMO, DIO and other health functionaries.

It was informed that about 39785 children in the age group of 0-5 years are being covered under Intensive Plus Polio (IPPI) Programme in the district for which 235 vaccination booths have been set up. Besides, 952 total workers have been deployed on duty which

include, , ASHA worker's, AW works, Health Workers, besides 52 supervisors.

At Bandipora, Deputy Commissioner Bandipora, Dr Owais Ahmad inaugurated the Intensified Pulse Polio Immunization (IPPI) Programme by administering polio drops to a child at District Hospital, Bandipora.

DDC informed that 62000 children upto 5 years of age are being administered polio vaccines to protect them against the crippling disease.

He said 360 vaccination centres have been established in snow bound Gurez Valley besides 22 mobile transit teams.

At Kulgam, Deputy Commissioner Kulgam, Dr.Bilal Mohi-Ud-Din Bhat started IPPI campaign by administering polio drops to new born children at District Hospital Kulgam.

On the occasion, the Deputy Commissioner added that more than 80 thousand children will be administered Pulse Polio drops.It was given out that 508 booths have been established in five medical blocks besides transit points have also been established for smooth and hassle free coverage of all eligible children.
