# CRIMEREPORT

## Illicit timber recovered; accused arrested

**BANDIPORA:** Police on Wednesday recovered illicit forest timber and arrested an accused.

As per details, acting on specific information regarding timber smuggling, a party from Police Post Aloosa under supervision of DySP Hqrs Bandipora at a checkpoint established at Aloosa Chowk intercepted a vehicle bearing registration number JK01K-4964 driven by one Mudasar Ahmad Dar, son of Mohd Yousf Dar, resident of Illahipora. During checking, huge quantity of illicit forest timber was recovered from vehicle. The accused, who is a notorious illicit timber, was arrested and shifted to police station where he remained in custody. Vehicle used in the crime was also seized. Accordingly, a case under relevant sections of law was registered in Police Station Bandipora and further investigation is going on.



## 4 drug peddlers arrested; contraband recovered

**G A N D E R B A L :** Continuing its efforts to eradicate menace of drugs from the society, Police on Wednesday arrested two drug peddlers in Ganderbal and recovered contraband substance from their possession.

As per details, officers from Police Post Shadipora under the supervision of DySP Hqrs Ganderbal at a checkpoint established at Khammohalla Pati Shalabugh road and intercepted a Maruti 800 bearing registration number JK01U-7177 with two persons onboard. During search, 22 Codeine Phosphate bottles were recovered from their possession. The accused, identified as Basit Gulam, son of Gh Mohammad Sheikh, resident of Padshahi Bagh, Srinagar and Ashiq Dar alias Nada, son of Abdul Hamid Dar, resident of Sarai Dangarpora Sumbal. They were arrested and shifted to police station where they remained in custody. The vehi-



cle was also seized. Accordingly, FIR No. 12/2022 under relevant sections of law was registered at Police Station Ganderbal and investigation started.

Two more drug peddlers were also arrested in Baramulla & Sopore and contraband substances was recovered from their possession. In Baramulla, officers from Police Station Uri under the supervision of SDPO Uri arrested one Shah nawaz Ahmad Mir, son of Mutwali Mir, resident of Daragutliyan Uri and recovered 38 gm Charas from his possession. He was shifted to police station where he remained in custody. Accordingly, a case under relevant sections of law has been registered in Police Station Uri and investigation started.

Similarly, a police party of Police Post Fruit Mandi at a checkpoint established at Achabal intercepted a Tavera bearing registration number JK01W-9880 driven by one Waseem Ahmad Wani, son of Ghulam Hassan Wani, resident of Zangam, Pattan. During checking, 100 capsules of Spasmaproxylon Plus were recovered from his possession. He was arrested and shifted to police station where he remained in custody. The vehicle was also seized. FIR No. 19/2022 under relevant sections of law was registered at Police Station Sopore and further investigation is going on.

## Fraudster arrested

**GANDERBAL:** Police on Wednesday arrested a fraudster for fleecing people on pretext of providing Government jobs.

As per details, Police Post Shadipora received a written complaint from one Tariq Ahmad Bhat, son of Ali Mohammad Bhat, resident of Hayan Palpora, Kangan stating therein that he has been duped by a fraudster identified as Amir Mehraj Parra alias Dr Amir, son of Mehraj-din Parra, resident of Zazuna Ganderbal who has taken a sum of Rs 5 lakh from him on pretext of providing Government job. FIR No. 06/2022 under relevant sections of law was registered at Police Station Ganderbal and further investigation started.

Subsequently, a special team headed by Incharge Police Post Shadipora was constituted to investigate the matter; during which it was revealed that the fraudster has cheated many people across Kashmir. Phone calls were also received from different people from across valley with same allegations and charges that the accused has cheated them by using same modus operandi.

It is pertinent to mention here that the accused used to get money in his account through different ways like MPay, Net Banking etc. and was beguiling the payee that he or she shall have a proof of transaction. Further investigation is under progress.

## Bootlegger arrested, illicit liquor seized
