

Bhalla, Refugee Congress leaders accuse Modi Govt of betrayal with DPs of 1947, 1965, 1971

JAMMU: JKPC Working President and Former Revenue Minister Raman Bhalla, Chief Spokesperson and former MLC Ravinder Sharma along with Refugee Congress leaders Pawan Raina Secretary JKPC, Sahil Sharma Spokesperson JKPC and Amrit Bali Vice Chairman Refugee Cell have strongly criticised the Central Govt. for closing the ongoing relief package for POJK, Chhamb DPs and termed it clear betrayal and backtracking of the promises with them by the Modi government and BJP.

Addressing the press conference at PCC HQ here on Thursday, Raman Bhalla along with other senior leaders reacted sharply to the recent notice of the government closing the relief package from 10th February

onwards, and termed it great betrayal with the suffering communities who were exploited by the ruling party by making hollow promises especially full implementation of the 2014 relief package recommended by then state coalition government on the initiative of Congress party and Dr Manmohan Singh government.

Bhalla said that BJP and Modi Govt befooled the POJK Refugees and sanctioned only the meagre amount of Rs 5.5 lakh per family against Rs 30 lakh per family recommended by the State Govt.

They questioned the closing of the ongoing package when all eligible families could not be even covered with the

installment of 5.5 lakhs per family, which was described as first installment but with the closing of the package, it is clear that there is nothing more for them, which is clear betrayal with them.

He said after long struggle of refugees of POJK, Chhamb, and hot perusal by the Congress, a package was worked out on the direction of Dr Manmohan Singh government in 2014 and recommended to the centre by state government.

It comprised of Rs 25 lakh per family as financial package besides jobs, reservation package and coverage of all left out DP families under land allotment and land deficiency categories, which was enhanced to Rs 30 lakh per family by the JPC.

The said package was not only endorsed by the all party joint parliamentary commit-

tee but also enhanced the relief amount to Rs 30 lakh per family, however the Modi Govt. and BJP failed to sanction the package. Only a meager amount of Rs 5.5 lakhs was sanctioned but that too has not been disbursed to all eligible families because of various hardships in the procedure and documentations for them. There are several hundred claimants pending and large number of others still deprived of the ongoing relief package.

Demanding sanction of full package of 2014 for them, without further delay, they announced that that Congress shall fully support the struggle of the refugees of POJK, and Chhamb for their due rights especially to get full benefits of the entire package endorsed by the parliamentary committee.



Waiving 50 pc passenger tax progressive move: CCI

JAMMU: The Chamber of Commerce and Industry (CCI) Jammu on Thursday termed the move of J&K Administration to waive off 50 percent passenger tax chargeable on various vehicles for one year as progressive and demanded that same should be abolished in J&K UT as it is not applicable in other Union Territories of the country.

The meeting held here today at the Chamber House was chaired by President CCI Jammu, Arun Gupta and attended among others by Sr. Vice President, Anil Gupta; Jr. Vice President, Rajeev Gupta; Secretary General, Gaurav Gupta; Secretary, Rajesh Gupta and Treasurer, Rajesh Gupta welcomed the recent decisions headed by LG Manoj Sinha to waive off 50 percent Passenger Tax Chargeable on various vehicles for one year from 1st April 2020 to 31st March 2021 asserting that the same will address genuine demand of operators of

commercial vehicles.

The Jammu Chamber appealed to the government to abolish the passenger tax once and for all as the same is not applicable in other UTs of the country.

The Chamber also appreciated the LG Manoj Sinha for constituting a 3-tier committee to demarcate "Gair Mumkin Khad" especially in 3 districts including Jammu, Kathua and Samba and for seeking report within three months.

"This will give a major relief to the people who are suffering because of erroneous/ misleading entries of such water bodies in their revenue records", the meeting said adding that the LG's initiative in this regard is quite appreciable and Chamber thanks him for showing magnanimity over the issue.

The CCI members anticipated that by redefining the Gair Mumkin Khads, the avenues for investments as desired by the LG Sinha will take a big leap as confusion

over the issue was marring the scope of the same over the last many years.

After threadbare discussion on the impact of continuous lockdowns in different forms in the UT of J&K, Chamber made a fervent appeal to J&K Administration to revisit the decision under the light of PM Modi's suggestion that the restrictions on account of COVID should not hinder the business activity and people's livelihood.

Arun Gupta appealed to the J&K Administration to completely lift all the restrictions which are hampering the business activity in Jammu Province as the same has become significant to ensure sustenance of businessmen fraternity in the region.

He said that COVID cases have also started showing considerable downfall therefore it is needful now to make an end to weekend lockdowns and give the businessmen a fair chance to earn livelihood and the trade to come back on rails once again.

CAT quashes selection of lecturer in super-specialty hospital

JAMMU: A Bench of Central Administrative Tribunal (CAT) at Jammu comprising Dr Bhagwan Sahai (A) and Rakesh Sagar Jain (J), while allowing petition filed by one Dr Rajeev Gupta, ordered that impugned selection list issued vide Notification no. 01-PSC (DR-S) of 2018 dated February 9, 2018 whereby respondent (Mohd Hussain Mir) was selected a Lecturer, Super Specialty Hospital (Medical Oncology) (GMC Jammu) was set aside and other respondents were directed to consider candidature of applicant for post of Lecturer within a period of one month.

As per the case, the applicant pleaded that he having qualification of MBBS, MD (Medicine) and DNB (Medical Oncology) and participated in various

national and international seminars, had applied for the post of Lecturer in Medical Oncology in Super Specialty Hospital, Government Medical College, Jammu in pursuance to notification No.:03-PSC (DR-P) of 2016 dated February 19, 2016 issued by Public Service Commission. The interview for the post of Medical Oncology was conducted on January 23, 2018 and thereafter respondent issued impugned final selection list, selecting respondent (Mohd Hussain Mir) instead of applicant despite fact that applicant is more meritorious. Moreover, certificate presented by the applicant regarding his participation as a speaker in the national and international seminars was not considered by experts and no marks were given for it

despite the fact that the applicant is entitled for the same.

CAT after hearing Adv Rohit Kohli for petitioner whereas Deputy AG Rajesh Thappa for the UT Govt and Adv FA Natnoo for PSC, observed that one can conceive a situation where the candidate happens to be a student of expert at one point of time and in that situation, we may agree with the argument of the counsel for respondent. In the present case, as per the assertion of counsel for the applicant, respondent was a student even on the date of interview and this assertion has not been denied by other respondents. With these observations, the CAT allowed petition and ordered that impugned selection list whereby respondent was selected as Lecturer Super Specialty Hospital (Medical Oncology) is set aside.

During the meeting, it was proposed that many

vendors in Rehri zones are causing havoc by throwing garbage in nearby open area, as such all Rehris should be provided a dustbin and if found spreading litter should be penalized. The participants also suggested that an amount of Rs 100 should be charged

from all street vendors. Corporator Pritam Singh proposed that Bahu Fort temple should be brought under shrine board so that it can be properly maintained and kept clean. The meeting ended with a vote of thanks by ACR JMC.

MJR-47 resents imposing cut-off date on submission of relief claims, seeks revocation

JAMMU: Movement for Justice for Refugees of 1947 (MJR-47) has sought immediate withdrawal of notice for fixing a time-limit on submission of relief claim of Rs 5.5 lakh by PoJK and Chhamb DPs. In a press statement issued here on Thursday, Chief Spokesperson, Suchwant Singh urged Disaster Management, Relief, Rehabilitation and Reconstruction department to withdraw notice imposing cut-off date for submission of claim of Rs 5.5 lakh in view of prevailing COVID pandemic and non-tracing of records by 4th-5th generations of PoJK and Chhamb DPs. The notification informing that no claim shall be entertained by DPs after Feb 10, 2022 is not only harsh and irrational but is arbitrary in nature as Govt cannot deny bare minimum relief installment to suffering DPs under a specific scheme, they added.

The MJR-47 members further said that notice is quite unexpected and is contrary to

the spirit of Supreme Court which has suo moto waived limitation period under all Acts during COVID pandemic. "Govt has already arrived at Rs 5,49,692 instead of Rs 5.50 lakh due to division of fixed sanctioned amount within 26,319 families from PoJK then how such family, in whom favour amount has been settled, be debarred of such relief amount. Apart from above, 5,300 PoJK DP families are residing outside J&K and 9,500 unregistered families have not been considered for the relief under scheme. Further, the Union Minister PMO, during a visit to Jammu along with the then Union Home Minister had promised on behalf of Prime Minister that relief amount of Rs 5.5 lakh is not full and final. The recommendations in packages made by then State Govt in 2014 as well as by DRPSC on Home Affairs in Dec 2014 have still to be sanctioned. Unless same are granted, no DP family can be considered to be settled and adequately compensated," they added.

CAT directs appointing petitioner as Asstt Prof Geography in open merit category

JAMMU: A Bench of Central Administrative Tribunal (CAT) at Jammu comprising Dr Bhagwan Sahai (A) and Rakesh Sagar Jain (J), directed to appoint petitioner Tajinder Kour as Assistant Professor in Geography under open merit category. CAT after hearing Sr Adv Abhinav Sharma with Adv Abhimanyu Sharma observed that even if executive instructions in form of Govt. Order No. 62-SW of 2001 dated January 13, 2001 are ignored, the respondent cannot apply the roster at his own sweet will, caprice and whims, as the Reservation Rules, 2005, with particular reference to Rule 5(2) stipulates that the roster shall be maintained as a running account from year to year and even if stand of the PSC is to be accepted in view of the judgment of the Supreme Court, in that eventuality also the first vacancy was required to be offered to handicapped category candidates in 2007, when 3 candidates were appointed and second was

required to be offered in 2014, when 43 vacancies were advertised, raising the total to 50 and, who knows at that point of time in 2014, handicapped category candidates were available or not and even if available, who knows to which category he or she belonged whether OM, SC, ST, ALC or RBA. Therefore, in no circumstances, the right of applicant could have been taken away by respondent.

With these observations, CAT allowed the petition and directed respondent PSC to recommend name of the applicant to Higher Education Department for her appointment as Assistant professor in Geography under OM category, pursuant to her selection made by J&K PSC vide notification No. 03-PSC (DR-S) of 2021 dated January 5, 2021 with all consequential benefits including notional seniority, and fixation of pay, though without any arrears of salary w.e.f. the date other selected candidates were appointed as Assistant Professors in other disciplines.
