

## J&K-FRIENDLY BUDGET

The present dispensation has always accorded a prioritized treatment to the Union Territory of Jammu and Kashmir in sanctioning welfare schemes and mega-infrastructure projects, after the bifurcation of the erstwhile state into two Union Territories, to ensure overall development and prosperity of J&K people. It is only due to the far-sighted policies and candid approach of the ruling dispensation that J&K, which just a few years back was struggling hard due to numerous challenges and apathy of successive Governments, is now marching proudly on the track of progress and prosperity. Providing a further huge bounce to the ongoing development works and infrastructure projects going on in the Union Territory, the present Government in the budget presented for financial year 2022-23 has granted a whopping amount of Rs 35,581.44 crore for the Union Territory, as special assistance, loans and grants under various programmes. Pertinent to mention here that this huge allocation in favour of Jammu & Kashmir is almost Rs 877 crore more than the amount granted to J&K during last financial year. Proving the commitment of the present Government to ensure overall development of J&K besides ensuring provision of all basic amenities at the doorsteps of people, in this year's budget the Government has laid special focus for development of industries and other infrastructure, especially in rural areas, in J&K. As per the details, the Union Finance Minister has taken special care of J&K as adequate funds have been allotted to ongoing projects like Institute of High Altitude Medicinal Plants at Bhadarwah, Ratle HE project, Kiru HE project etc. Moreover, special funds amounting to Rs 225 crore have been earmarked for J&K Special Scholarship Scheme. Taking special care of the rural areas especially those located near the Borders, a special scheme Vibrant Villages Programme was also announced under which various ultra-modern facilities, like tourist centres, road connectivity, infrastructure etc, will be made available at these rural places to take them at par with urban areas and special allocation have been made for the purpose. Moreover, to provide a sigh of relief to the ailing industry sector due to ongoing pandemic and lockdowns imposed as precautionary measure, special budgetary provisions have also been made for the industries of J&K. Although, a lot of other decisions, which were expected by people, are not there in the budget yet one can term it a J&K-friendly budget.

## STOP ACID ATTACKS

The acid attacks on women is such a heinous crime that the whole society should stand against it without any exception and those involved in crime must be given the most stringent punishment to set an example that no one dares to even think of doing such kind of misadventure. Acid attacks on women in the country are the nastiest and the most horrendous kind of violence committed on weaker sex. Though J&K has less number of such cases but even one is enough to put a blot on the crime graph and is testimony to fact that police is a bit complacent regarding implantation of the Supreme Court ruling over regulating the sale of acid as availability of this weapon in itself is kind of abetment to the crime. Those found involved in contempt of Apex Court order should be taken to task as this is quite serious matter because lives of womenfolk is involved. The misery of girls and women facing such attacks is so dreadful that there are no words to explain the exact feeling. It is high time now to bring some stringent law to curb this most horrendous crime from the society because hollowness prevalent in administration and inability of toothless judiciary has miserably failed to stop this barbarism from happening.

# Cancer awareness & medical sciences

Cancer is a complex disease which has been taking heavy toll of human lives followed by Cardio and Corona due to presently limited available resources for diagnosis, cure, preventive, financial & social support leaving behind the patient in lurch and their dear ones with experiences and suffering throughout life. Although medical science is progressing and there are advancements in research day by day, yet rise in this dreadful disease for known/ unknown reasons is alarming as witnessed by long queue of patients visiting hospitals for treatment. There is dire need to bring efficiency in medical services, modernise early investigation/ necessary know-hows of advanced gadgets and act fast to save humanity from clutches of uncertainty & agony especially due to overcrowding of patients/ dearth of specialists etc at treating Centers. Everyone is entitled to use whatever language they want to describe their own experiences. I had depicted the exact picture of agony faced by patient and the caretakers 5 decades ago, in my article last year.

No medicine has been invented for Cancer till date. Surgery, radiation and chemo administered medicine is used as a supplement and not as basic. Even for corona, medicine invented besides vaccine. We do not know why the scientists and nuclear scientists and doctors engaged in research are reluctant to invest their heart and mind into it or whether some vested interests are behind it and blocking / preventing inventions. Yet, there still exists a prevailing attitude to cancer which treats survival as though it were somehow an act or Will of God. You've got to be strong, remain positive and be courageous to overcome the disease. A positive attitude is important to overall health and study too suggests that a bright outlook could play a major role in how someone handles cancer treatments. If there is suffering, the palliative care has to step in, hand in hand with treatment of disease. And when disease becomes incurable, palliative care continues to improve quality of life...even during bereavement process. Reality,

death is the inevitable consequences of every life. The weeks or months preceding death can become a precious time, rebuilding connections, giving love and receiving love. The medical system needs to understand that it does not have a duty to prolong the dying process, when disease is advanced and treatment is obviously futile. Relatives may want to do everything to keep the person alive; they need to be helped to come to a state of acceptance.

As per latest research reports, 'Heartbreaking reality....they need affection, social interaction and practical and emotional support, help, support...to manage the consequences after being diagnosed and treated. Those lacked such support and having some-

one to talk or help with household chores, are at greater risk.' A new blood test is being launched in the United States called Galleri that can potentially detect more than 50 different kinds of cancer. Pronounced like 'gallery,' the makers of the test say it has very few false positives and can pinpoint what specific part of the body a cancer signal is coming from. This new blood test can detect 50 types of Cancers. Not just COVID, mRNA Vaccines could cure Cancer in a few years. COVID was only the first step - more than 150 m RNA Vaccines are now being developed for diseases ranging from the FLU to HIV. New research from Italy, suggests that physical activity ramps up movement of Cancer - fighting molecules in the body and weakens the cancer promoting ones. Adults should get at least at least 150 minutes of moderate- intensity exercise, such as biking or brisk walking, per week. In fact, Genes cause upto 1 in 10 cancers. Life style and the world around us can explain the other 9.

In Kurukshetra University, scientists discover toxins that fight Cancer. The paper states, 'Microbial toxins derived naturally as a therapy against cancer cells are a promising new dimension. These toxics have diverse mechanisms of actions. Further, these agents act on different bio targets such as reduction in cell growth, regulation of cell cycle, inhibitions of protein synthesis and many

other processes.' Cancer is not a death warrant. The secret is to catch it in good time well before it can spread and then there are reasonable chances that it can be cured. 'Just 2 doses of vaccines for girls of age group 9 to 14 years and 3 for older girls upto 26 years and beyond can prevent Cervical cancer in them. It is just as simple as that.'

Regarding Breast Cancer, the early signs and symptoms after witnessing which, the girls should immediately go for a professional check-up. For Lung cancer, targeted therapy and immunotherapy are the future of oncology treatment as chemotherapy has toxic side effects. Further, the technique on Sleeve Resection will help in adequate resection of the tumour and thereafter quick recovery.

Inputs from health and other experts and studies made it clear that drinking water is not safe in J&K. Govt and scientific institutions need to do many studies on contamination of drinking water sources by pesticides. A study by Prof Abdul Rashid Bhat, a neuro-surgeon and others from the S K Institute of Medical Sciences, Srinagar, linked pesticides to brain cancer. The report was published in Indian Journal of Medical and Paediatric Oncology in Oct 2010. Guava is abundant with cancer-fighting antioxidants Lycopene. The phyto-chemical lycopene is good for the treatment and combating of cancers such as prostate and breast cancer. For cancer diseases, one should prefer red-fleshed guava over other varieties of Guavas. The other nutrients such as Vitamin-A, vitamin C, fibre, flavonoids, beta-carotene, lutein and cryptoxanthin along with antioxidants also help to fight free radical cells which credit to cause cancer. The new budget caters to the needs and hopes of various sections of the economy and society and thus it meets the expectations of the various segments of the society. The current budget exercise is futuristic one with 25 years in mind and it is a balanced budget with a balanced outlook as it involves long term planning as it meets the expectations of various segments of the society. The budget emphasizes sharp increase in the expenditure on the infrastructure development and thus it will lead to the laying of the highways and roads which in turn will lead to the development of the economy of the country. The thrust on the infrastructure development is the important characteristic of the current union budget and it is surely aimed at the long term development of the economy. The investment on the infrastructure development is expected to grow the economy at the rate of 9.27 percent per annum which is really a matter of satisfaction. The budget has been unveiled for the fiscal year 2022-23 with an aim to boost growth amid COVID-19 and rising inflation. The budget provisions aim at having some control on the burning problem of inflation as some relief will be given to people so that they will have a sigh of relief and this is a welcome development. ## YOUR COLUMN Take care of Sumb-Goran road

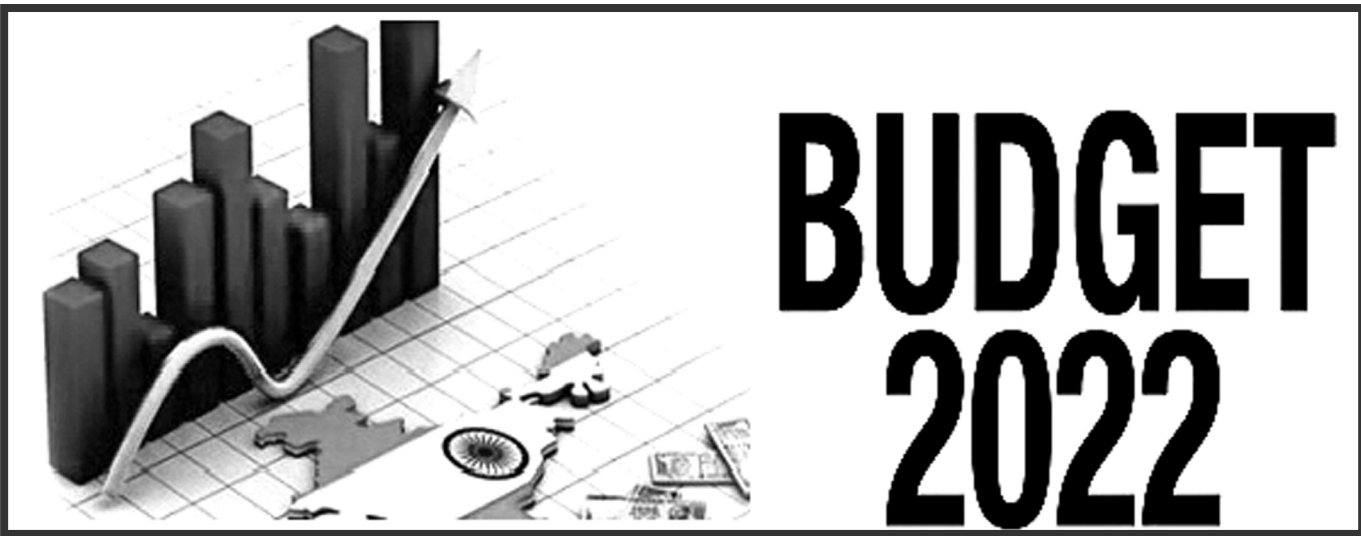

above all the women which are about half of our population. The budget is going to lay a strong foundation for sustainable and self sufficient -Atamirbar Bharat. It is a futuristic and far sighted budget which will lead to the development and growth of the economy and make the dream of Atamirbar Bharat a reality and not confine it to cheap slogan only. The budget will ensure jobs to the unemployed youth on a big scale. It will also lead to revolution of digital education in the country. It is a well managed budget within the available resources. The provision of extension upto march 2023 in ECLGS with an expanded cover of Rs 5 lakh crore is a big relief to the micro, small and medium enterprises called popularly MSMES. employment. The elimination of 75,000 compliances and repeal of 1486 centre laws is a revolutionary step which is going to lead to development in the economy. The digital India campaign will also get a boost due to the provision of 5GSpectrum and it will make development of the country possible. It is so good that there is trust on making India Atamirbar and 5 trillion economies in the near future. The budget is in fact a people friendly budget. India's growth is expected to be at 9.27 per cent highest than all large economies. It is a matter of some satisfaction for the countrymen. The effective capital expenditure of the union government is estimated at rupees 10.68 lakh crore in 2022-23 which is about 4.1 per cent of the GDP. Total expenditure is expected at rupees 39.45 lakh crore. The receipts are estimated at rupees 22.84 lakh crore. There will be big public investments which will benefit youth, women, farmers, SC, ST and other excluded masses and shall be helped by novel mechanism of PM Gati Shakti. All this will become a reality through focus on macroeconomic growth, micro economic welfare focusing on improvement on digital economy. The finance minister stated that digital rupee will be issued using block chain technology by the reserve bank starting 2022-23. This is going to give a big boost to the economy. She also informed that income from the transfer of any virtual digital asset shall be taxed at the rate of 30 percent. The budget sets an outlay of Rs 48,000 crore for construction of 80 lakh houses for the poor under Pradhan Mantri Awas Yojana in rural and urban areas in the budget period. There is special thrust on the agriculture and a provision of the amount of rupees of 2.37 lakh crore towards direct payment for minimum support price for the produce and this is a welcome development.

There is special stress on education and health sectors. One class one TV channel program of PM e-VIDYA will be expanded from 12 to 200 TV channels. This will enable all the states to provide supplementary education in regional languages for classes I to 12. There is a provision for the establishment of a digital university to boost education. There is provision for 60 lakh new jobs for the unemployed youth of the country and it is praise worthy step. There is provision for safe drinking water for the consumers and an amount of Rs 60,000 crore has been earmarked for the purpose of providing tape water to the people. Thus the budget is a progressive, inclusive and development oriented and pro poor and it will certainly lead to the development of the various sectors of the economy. The budget 2022-23 is a revolutionary one which is aimed at the overall development of the economy.
