TERMS AND CONDITIONS

a) For PSC (In-Service) Candidates:-

- The In-service doctor shall be paid salary as per their LPC.
- The In-service doctor shall be allowed to participate in the selection process only with the prior permission of the Administrative Department as per circular No. 05-JK (HME) of 2021 dated: 21-12-2021 read with circular No. 02-JK(HME) of 2020 dated 20-01-2020 and Govt. order No. 03-HME of 2019 dated 27-05-2019. For the purpose they should route their application forms through the Administrative Department. No advance copy shall be entertained. No candidate shall be allowed to sit in the interview without prior approval.
- In case of selection, they will be allowed to join only after being relieved from their Administrative Department.

b.) FOR CANDIDATES WHO ARE NOT IN GOVT. SERVICE:- (Non-PSC Candidates)

- The Non-PSC doctors shall be engaged on consolidated pay equal to the revised basic pay which corresponds to the minimum of the pre-revised scale for post of Medical Officer in Health Department as per SRO-193 dated 24-04-2016 + dearness allowance. The appointee shall also be entitled to house rent allowance as applicable to in-service candidates carrying the minimum of the pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard. An appointee shall not be entitled to any other monetary benefits whatsoever.

Maximum age for eligibility to apply shall be 60 years as on cut-off date.

Note: It is the sole responsibility of the applicant that the documents attached with the application should be legible and properly arranged in a series as mentioned in the advertisement notice. 5. All the e-Bids must be accompanied by the scanned copy of EMD in the form of CDR/FDR/Bank Guarantee only from any Nationalized/Scheduled bank only pledged to *Executive Engineer Electric Division, JPDCCL Batote*. No Interest shall be payable on Earnest Money deposited with the Department.

7. The JPDCCL reserves the right to cancel any or all the e-Bids/ the e-Bid process without assigning any reason thereof if any major lapse/deviation is found. The decision of the JPDCCL will be final and binding.

8. In the event of date specified for e-Bids opening being declared a holiday for JPDCCL office then the due date for opening of e-Bids shall be the following working day at the appointed time and place.

9. All the required documents excluding Price Schedule/BOQ should be uploaded by the e-Bidders electronically in the PDF format, whereas Price Schedule/BOQ should be uploaded electronically in the same BOQ sheet provided with the SBD.

10. To participate in e-bidding process
