Subject: Declaration of result of Shri Dalbir Singh Sudan S/o. Gurucharan Singh Sudan, Roll No. 3100505 for the post of Veterinary Assistant Surgeon in Animal & Sheep Husbandry Department.

Notification No: PSC/Exam/02/2022

Dated: 01-02-2022

Whereas, the Commission vide Notification No: PSC/Exam/31/2019 dated 10.04.2019 invited applications for the post of Veterinary Assistant Surgeon in Animal & Sheep Husbandry Department and in response to the notification, 734 applications were received; and

Whereas, among others, Shri Dalbir Singh Sudan, has also applied for the said post; and

Whereas, on scrutiny of the application forms, it was found that Shri Dalbir Singh Sudan had submitted two applications forms i.e one under OM and other under ALC category for the said post; and

Whereas, the Commission issued a show cause notice on 19.05.2019 directing him to explain his position for filing of two application forms. In response, to which the candidate filed an appeal, stating therein that he has filled his form under OM category, as his ALC category certificate was under process, but in due course of time his ALC category certificate got completed within the stipulated time, so he filed another application under ALC category also; and

Whereas, the case of the said candidate was placed before the Appellate Authority of the Commission and the committee allowed him to appear in the examination on provisional basis with the following observations:-

"The candidate be as of now considered under OM category, but his result be kept on hold. Disciplinary action can be proposed subsequently only after the commission comes to know whether the candidate is in possession of the ALC certificate. ALC document has to be produced by the candidate in any case; and

Whereas, the said candidate was allowed to appear in the examination but his result was kept withheld. In the meantime, his case was placed before the Unfair-means committee of the Commission and the observations of the committee are produced as under:

"The ALC certificate produced by the candidate is within the cutoff date. ALC certificate has been issued on 02.05.2019, whereas the last date of filing of applications was 10.05.2019. However, filing of 02 applications is a negative point. The matter needs to be discussed in the Commission for arriving at the final conclusion viz-viz ALC category; and

Whereas, the case of Shri Dalbir Singh Sudan was placed before the Commission and the Commission in its 32nd Extra Ordinary Meeting of the Commission held on 22.10.2019 decided his case, with the direction produced as under:-

"The Commission came to the conclusion unanimously that the rules regarding suppression of facts intentionally are not applicable in face of the circumstances of the case where the candidate has had no option except to submit another application once armed with ALC certificate. The candidate had applied under OM category when ALC certificate was not available (under process) and the Commission allowed him to appear under said category till his status is decided on the basis of the 2nd application filed as ALC candidate after same certificate issued to him before the cut off eligibility. The matter was also discussed threadbare in the backdrop of the report of the Disciplinary Committee and it became evident that the status of the candidate under ALC category is now clear from his ALC Certificate and since earlier decision to allow the candidate to appear under OM category was conditional, therefore, the Commission approved that the candidate be consider under ALC Category and his result to be declared under ALC category; and

Whereas, in the meantime, the earlier Commission got dissolved and the result of the Dr. Dalbir Singh could not be declared in absence of the Commission. The case of Dr. Dalbir Singh was also erroneously tagged with the court case of the Kamika Malsajan, an OM category candidate, who had obtained an interim order for keeping one post reserved from amongst unfilled posts. The matter was taken with Standing Counsel of the Commission, who was of the opinion that the vacancy under ALC Category can be filled up and there is no hitch in concluding the selection under ALC category. In the meantime, the Hon'ble CAT has modified its earlier order 16.07.2019, which reads as under:

"In the meantime, subject to objections from the other side, and till next date of hearing, out of notified vacancies of Veterinary Assistant Surgeons (General Category) under open merit, if has remained unfilled so far, shall not be filled up."

Now, in view of the above, the result of said candidate is hereby declared for the Post of Veterinary Assistant Surgeon under ALC category and is produced as under:-
