- 1. Women candidate must be in the age group of 18-37 years as on 01-01-2023 shall be considered for the post.
- 2. The candidate should be a domicile of the UT of J&K.
- The candidate should be a resident of the electoral ward where AWC is situated. Name in the vote list for the ward shall be considered as the proof of residence of the candidate.
