# SHRADHANJALI

The remarkable life journey of **Gyani Surjit Singh Ji**,  
Ex-Army Veteran, Phenomenal social servant and an  
inspirational Religious Preacher, is so impactfully purposeful that  
it can never be expressed in mere words. His life journey of 90  
years has left an incredible mark through a multifaceted approach  
dedicated to the national and social service with a blend of  
valorous military career, commendable social work and edifying  
religious leadership.

Born in 1933, Gyani Surjit Singh ji embarked on a life of discipline  
and commitment early on. Joining the army at a young age of 18  
years in 1950 was marked by courage, leadership, valour and a  
strong sense of duty. He served the nation for long 36 years in the  
prestigious Infantry units of 18th Sikh, 1st Sikh (4 Mech.), SRC  
and 2nd Sikh with distinction, earning honorary accolades, medals  
and commendations. He had the honour of serving the nation  
during three important wars of 1962, 1965 and 1971 with a valor-  
ous display of bravery and sincere duty.

After an esteemed military service of 36 years, he didn't rest on his  
laurels rather regenerated his energy, wisdom and divine inner  
strength driven by a deep sense of empathy and transitioned seamlessly into the realm of social and  
religious service. Realizing the spiritual supremacy and religious wisdom of Gyani Surjit Singh ji, late  
Mahant Bachitar Singh Ji appointed him as the Chairman of '**Dharam Prachar Committee**' where  
Gyani ji had the honour of resolving numerous marital issues of young couples with positive outcome of  
reconnecting them. Gyani Ji spearheaded many such initiatives that led to the evolution of optimism  
encapsulated with progressive mindset and ancient social and religious values. Since Gyani Surjit Singh  
ji was an encyclopedia of religion and ethics; he was honoured to be appointed as the Head of '**Paanch  
Piyaras**' by respected Mahant Manjit Singh Ji to conduct the divine religious ceremony of '**Amrit  
Sanchar**'. The synthesis of his military discipline and compassion reflected in his approach to spiritual  
teachings, making him a source of divinity and inspiration.

He was blessed to be married to a great pious life partner, late Sdr. Jatinder Kaur, who was the hidden  
source of motivation and strength for Gyani Ji during all thick and thin times of their life together. Gyani  
ji is blessed with four obedient and well-read sons and two very empathic and independent daughters. His  
eldest son retired as SDO in Agriculture Deptt, followed by second son who carried the legacy of military  
service and retired as Colonel. His third son is not only carrying his legacy of religious optimism but also  
has a successful career as Lecturer of Computer Science in Education Department. His youngest son is  
a senior officer in Geology Mining Department. Both his daughters are in Education Department, one is  
heading a Higher Secondary School as Principal and the other daughter is a senior master in Higher  
Secondary School. He was fortunate to have highly qualified and successful daughters in law and sons in  
law. He was blessed to have a legacy of sharp-mined grand-children as well as great grand-children with  
an absolute empathic personality. His family is the reflection of his exemplary life that exhibited an aura  
of optimism all around.

Gyani Surjit Singh Ji stands as a paragon of life well-lived, a harmonious blend of military valour,  
humanitarian service and spiritual enlightenment. His legacy continues to inspire generations  
reinforcing the belief that one such pious soul can make huge difference in the world.
