



3 Chemist shops sealed for selling H1 drugs illegally

During inspection of 'Ajay Medicos' chemist shop at Zero Morh Ialwara, the retailer namely Ajay Singh, son of Naseeb Singh, resident of Salal Kotli, Tehsil and District-Reasi was unable to provide the record of H1 drugs and also CCTV cameras has not found in his shop. Due to which the shop has been seized/closed under 22 D of drugs and cosmetic act 1940.

Similarly during inspection of 'Navh Medical Hall' Chemist shop, at Zero Morh Talwara, the retailer namely Munna Abrol, son of Shashi Pal Abrol, residnet of Reasi was unable to provide the record of H1 drugs and also CCTV cameras has not found in his shop. In 'Satya Medical Hall' at Seela, Reasi, the retailer namely Sahaj Kumar,s on of Munshi Ram, resident of Vijayapur, Reasi also selling H1 drugs illegally and did not maintain the record of H1 drugs and CCTV Cameras has not found in his shop.

In this regard, all the three Chemist shops have been seized/closed under 22 D of drugs and cosmetic act 1940.

The whole operation was led by SHO Reasi under the supervision of Dy.SP headquarter Neeraj Padyar.

DMO further informed that the trucks were loaded with gypsum in Samba areas and were on their way towards Punjab but they were not carrying any valid documents with them which are required to transport mineral from one location to other.

After seizing the trucks Deputy Commissioner Kathua and Director Geology and Mining, J&K were immediately apprised about illegal transportation of gypsum from the mining leases and also from the premises of unauthorized dealers who supply such mineral in violation of rules.

During questioning accused confessed their involvement in the above case and on their disclosure stolen tractor along with trolley bearing registration No. JK02N-2061, stolen in case FIR No.10/2024 and 5.5 quintal of paddy crops stolen in case FIR No.37/2024 have been recovered. Moreover two other motorcycles 1. Hero Splendor bearing chassis MBLHAR086JHM57862 and 2. Motorcycle bearing chassis No. MBLHAW114NHF92735 have also been recovered from their




