Whereas, after issuance of the seniority, the Directorates of School Education, Jammu/Kashmir forwarded the service particulars/bio-data of some PG Masters/Teachers in the discipline of Computer Science for inclusion in the seniority list; and

Whereas, in light of Government Order No. 940-Edu of 2017, dated 17.11.2017 proper permission and admissibility of leave is required from the competent authority at the relevant point of time for pursuing PG degree during service; and

Whereas, the Department has examined the issue thoroughly and it has been observed that some incumbents have pursued their PG degree during service through Regular/Distance mode without obtaining proper permission/leave from the competent authority (Administrative Department); and

Whereas, the objections filed by the incumbents for additions/deletions/corrections have been examined in the Department, and the incumbents who have obtained their PG degrees through regular/distance mode during service without obtaining proper permission/leave from the competent authority have been included in the Seniority list, with the condition that their inclusion in the seniority and promotion shall be subject to the condition that permission for pursuing PG degree during service is granted by the competent authority on merits; and

Whereas, an exercise has been made in the Department and a tentative seniority list as it stood on 01-01-2024 has been prepared and annexed as Annexure-A for inviting objections from members of the cadre who either are not included or are aggrieved with their service particulars / position assigned to them in the tentative seniority list.

A. Anganwadi Helpers

- The selection of Helper shall be restricted to the electoral ward where Anganwadi Centre is located.
- Women candidates in the age group of 18-37 years shall be eligible.
- The candidate must be domicile of the UT of J&K.
- Minimum qualification for Anganwadi Helper shall be matriculation.
- In case no matriculate candidate available in the ward, candidates with qualification not less than 8th standard shall be considered.
- The committee shall select the most destitute/needy married woman of the ward as helper from amongst those who fulfill the qualification criteria. In case no married candidate is available, unmarried candidate may be considered.

B. In case eligible candidate is available within the family of retiring AWWs, the said candidate shall qualify for additional two percent points.

Certificates Required

- Domicile Certificate.
- 10th/12th and Graduation Mark Sheet in case of Sanginis (AWWs) & 10th Mark Sheet of school education / University in case of Sahayikas(AWHs).
- Date of Birth/Matriculation Certificate.
- Residence/Ward certificate where the vacancy has been verified from concerned BDO.
- Voter list of concerned ward where post have been available.
- UnMarried certificate issued by concerned Tehsilidar in case of name of the candidate appeared in voter list with her parents.
- Certificate from concerned Sarpanch in case of candidate belongs to the family of retired AWW.
- Death Certificate in case of widow/divorcee copy in case of candidate applying for Sahayikas(AWH) for considering most destitute/needy.
- Affidavit duly attested by Judicial Magistrate/ Executive Magistrate 1st Class as shown in Annexure "B".
