SRINAGAR: The Divisional Commissioner (Div Com) Kashmir, Vijay Kumar Bidhuri on Monday convened a meeting of Officers, here to discuss developmental issues of Rakh-I Arth Housing Colony Bemina Srinagar. It was also given out that the area is fed from Sukhnag water supply scheme, and to further augment it, the water supply shall be improved through tube wells. Regarding electricity, it was informed that the electricity shall be augmented as DPR reappraisal has also been submitted.

To ensure proper sanitation in the area, the Div Com directed the SMC to issue a tender for Solid Waste Management. The Div Com took strong note of encroachments in the area and directed the concerned to remove the same forthwith.

5. The bidders are requested to quote their rates excluding GST. GST @18% shall be added to the contract value by the allotting authority at the time of issue of allotment.

A Pre-bid meeting will be held on 24-02-2024 at 11:30 AM in the Office of Executive Engineer PMGSY (JKRRDA) Division Uri to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9 of instruction to bidders of the Bidding documents. **The intending Bidders, before attending the Pre-bid meeting, are advised to visit the site of work and acquaint themselves with the site conditions. It has been made mandatory for all the intending bidders to participate in the pre-bid meeting on the scheduled date and time.**
