On the recommendations of the J&K Services Selection Board, sanction is hereby accorded to the appointment of Mr. Rashad Amin Khan, S/O Muhammad Amin Khan, R/O H No 33, Cheepora, Mandanpora, Lalpora, Kupwara under RBA category as Driver-II in the Jammu & Kashmir Energy Development Agency (JAKEDA), Science and Technology Department in the Pay Level 2(Rs 19900-63200), with immediate effect.

The appointee shall report to the Chief Executive Officer, Jammu & Kashmir Energy Development Agency, Science and Technology Department, within a period of twenty one (21) days from the date of issuance of this order failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled *ab-initio* without any further Notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- Academic/Technical Qualification Certificates.
- Matriculation/Date of Birth Certificate.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Domicile Certificate issued by the Competent Authority.
- Valid relevant Category Certificate.

The appointment of the above candidate shall further be subject to the following conditions:

- The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his appointment as Driver-II in the Jammu & Kashmir Energy Development Agency, Science and Technology Department shall be deemed to have been cancelled *ab-initio* and the legal action as warranted under rules shall be initiated against him.
- That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate are received from the concerned Authorities/Agency.
- The appointee shall be on probation for a period of two years.
- The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- The inter-se-seniority of the appointee in the Jammu & Kashmir Energy Development Agency, Science and Technology Department shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- The appointment of the above appointee shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.

ELIGIBILITY CRITERIA FOR SELECTION OF SANGINIS (ANGANWADI WORKERS)

- Women candidates in the age group of 18-37 years as on 01-01-2024 shall be considered for the post.
- The candidate should be a domicile of the UT of J&K.
- The candidate should be a resident of the Electoral Ward where AWC is situated. Name in the voter list for the ward shall be considered as the proof of residence of the candidate. In case the name of the candidate appears in Voter list along with her parents, then she must provide certificate of being unmarried issued by concerned Tehsildar. Wherever, there is any dispute of residence for any reason, then a residence proof certifying the ward of residence from the concerned SMD/ACR shall be considered.
- Minimum qualification for Sanginis (Anganwadi Worker) shall be 10+2 and maximum graduation. In case no 10+2 pass candidate is available in the ward, 10+2 pass candidate from the adjoining ward shall be considered.
- In case suitable candidate is not available from adjoining Ward, candidate from the nearest Ward within the Panchayat can be considered.
- Weightage shall be given on the basis of marks obtained in 10+2 and selection shall be done purely on merit basis and no other criteria to be considered.
- In case eligible candidate is available within the family of the retiring AWW/AWH, the said candidate shall qualify for additional two percent points.
- In case of tie in merit of the eligible candidate, candidate with higher age will be preferred.
- Candidates with qualification higher than graduation shall not be considered.

ELIGIBILITY CRITERIA FOR SELECTION OF SAHAYIKAS (ANGANWADI HELPERS)

- The selection of Sahayikas (Anganwadi Helper) shall be restricted to the electoral ward where Anganwadi Centre is located.
- Women candidates in the age group of 18-37 years as on 01-01-2024 shall be considered for the post.
- The candidate should be a domicile of the UT of J&K.
- Minimum qualification for Sahayikas (Anganwadi Helper) shall be Matriculation.
- The first and the foremost criteria of eligibility amongst married women in case of Sahayikas (Anganwadi Helpers) is the marks obtained in the class 10th. However, in rarest of rare cases where Selection Committee finds a widow headed household with no income source or a completely destitute lady with zero source of income, in such cases preference may be given if other things are equal.
- In case no matriculate candidate is available in the Ward, candidates with qualification not less than VIII standard shall be considered.
- In case no married candidate is available, unmarried candidate may be considered. The condition regarding unmarried candidates being selected only if no married candidate is available be also adhered

to.
