44 years in the case of Ex-servicemen.

40 years in the case of candidates in Government Service/ Contractual employees;

are in possession of the prescribed academic/professional/technical qualifications and fulfill all other eligibility conditions, as prescribed in Annexure-A, before last date of submission of application forms i.e., 18.03.2024.

have deposited fee of Rs. 400/- (Rupees Four Hundred Only).

Applications along with the prescribed fee will be received only through online mode on recruitment portal of the High Court of Jammu and Kashmir link of which will be activated on 03.03.2024 on the website of the High Court: https://www.jkhighcourt.nic.in.

Submission of Application Forms and fee payment shall not be accepted/entertained after the cut-off date fixed for receipt of the same. Candidates shall not submit the printout of the Application Form/fee payment receipt to the office of Registrar Recruitment, High Court of J&K and Ladakh at this stage.

The reservation for various categories would be determined as per the provisions of S.O. 127 dated 20.04.2020.

Please note that the above procedure is the only valid procedure for applying. In no other mode, the Application Form would be accepted and concerned Head of Department. In the event of failure of the candidate to route the application through proper channel, his/her eligibility shall be assessed as if he/she is not an in-service candidate. The Head of Department concerned shall forward the application form of the in-service candidates at the address of the Registrar Recruitment, High Court of J&K and Ladakh, Janipura, Jammu, within 15 days after the last date of filling their Application form.

The last date for submission of online application forms as prescribed above shall be the cut-off date for determining the eligibility to apply for the post. The age limit, however, is determinable with reference to the 1st of January, 2024. Any qualification/experience acquired after last date of receipt/submission of online application form i.e., 18-03-2024 shall not be taken into account for any purpose.

The prescribed qualifications reflect the bare minimum requirement of the job and mere possession thereof shall not entitle a candidate to be called for written test.

The criteria and syllabus for the test for the selection to the post of Telephone Operator has been made available on the official website of the High Court of J&K and Ladakh.

The eligible candidates shall have to appear in the test on the date(s) notified separately. No separate call letters shall be issued individually; however, wide publicity shall be given through print and electronic media, official website https://www.jkhighcourt.nic.in of the High Court about the venues, dates of written test/ interview for the information of eligible candidates. No claim of being unaware of the dates/schedule for written test/interview shall be entertained.

CRITERIA FOR SELECTION OF SANGINIS (ANGANWADI WORKERS)

1. Women candidate must be in the age group of 18-37 years as on 01-01-2023 shall be considered for the post.

2. The candidate should be a domicile of the UT of J&K.

3. The candidate should be a resident of the electoral ward where AWC is situated. Name in the voter list for the ward shall be considered as the proof of residence of the candidate. In case the name of the candidate appears in Voter list along with her parents, then she must provide certificate of being unmarried issued by the concerned Tehsildar. Wherever, there is any dispute of residence for any reason, then a residence proof certifying the ward of residence from the concerned SDM/ACR shall be considered.

4. Minimum qualification for Sangini shall be 10+2 and maximum graduation.

5. In case suitable candidate is not available from existing ward, candidate from the adjoining ward within the Panchayat can be considered.

6. Weightage shall be given on the basis of marks obtained in 10+2 and selection shall be done purely on merit basis and no other criteria to be considered.

7. In case any eligible candidate is available within the family of the retiring AWW/AWH, the said candidate shall qualify for additional two percent points while making selection.

8. In case of tie in merit of the eligible candidate, candidate with higher age will be preferred.

9. Candidates with qualification higher than graduation shall not be considered.

CRITERIA FOR ELECTION OF SAHAYIKAS (ANGANWADI HELPERS)

1. Women candidates in the age group of 18-37 years as on 01-01-2023 shall be considered for the post.

2. The candidate should be a domicile of the UT of J&K.

3. The selection of Sahayikas shall be restricted to the electoral ward where Anganwadi Centre is located. 4 Minimum qualification for Sahayikas shall be Matriculation.

5. In case no matriculate candidate is available in the ward, candidates with qualification not less than 8th standard shall be considered.

6. Merit (marks obtained in class 10th) to be considered while selection of the candidate. However, in rarest of rare cases where selection committee finds a widow headed household with no income source or a completely destitute lady with zero source of income, in such cases preference may be given if other things are equal.

7. Unmarried candidate being selected only if no married candidate applied.

HOW TO APPLY:
