

Besides sports he had a great interest in Music and poetry, a born natural singer he had a melodious voice and loved singing especially Gazals, because of which he was the life of all the gatherings and get togethers. He was a friend to every age group and used to easily mingle with children, youngsters and adults alike. He loved spending time with his grandchildren and was very fond of sharing his life experiences with them.

He got married to Late Smt. Uma Bakshi in the year 1968 and was blessed with four children, a son and 3 daughters. His son Mr. Rajesh Bakshi, is currently serving as Chief Prosecuting Officer in Anti-Corruption Bureau Jammu, and is married to Mrs. Vidushi Bakshi who is a Govt. teacher. They both are blessed with 2 children a daughter Vanshika Bakshi and a son Aryamann Bakshi. He was awarded with Governor's Police medal and D.G.P Police medal for his meritorious services for the police department.
