

But unfortunately after the death of his father he felt alone and decided to shift Jammu under the inspiration of his God Father Lala Jagat Ram Mahajan.He started the business at Fruit Mandi as a FruitVendor at Parade and after that he does not look back and during the course of time also settled his brothers and

sisters in Jammu. He was blessed with two sons and five daughters. He also worked with Praja Parishad as social Worker. He was not in favour of dowry system and was strictly against thatevenat the time of marriage of his sons he does not take a penny in shape of dowry .He also contributed a lot for marriages of poor girls.He also served for Mahajan Baradari and worked on grant of Widow Pension also. He was alsoSr.Vice President of Karyana Union for sixteen Years.During his tenure he helped a lot for small shopkeepers especially during the time of product sampling. He has also served as President of Kerosene oil Dealers Association. He has also spend lot of valuable time on religious activities at HarKi Poudi mandir situated at Bhag-e Bahu Jammu.After that he joined National Conference and served a lot for the community. He was also a member of Ware House Association and has received award form Association. At the age of 87 he left for heavenly abode with all the memories left behind. He will be always remembered for his social and religious activities .His legacy continues to inspire generations reinforcing the belief that one such Pious Soul can make huge difference in the world.


