SAMBA/UDHAMPUR: Tightening noose against the bovine smugglers and their propagators, Samba Police has today foiled a major bovine smuggling attempt in the jurisdiction of Police Station Samba and rescued thirty one bovines from the clutches of bovine smugglers. The vehicle used



for illegal transportation of bovines was also seized.

An information was received at Police Station Samba from reliable sources regarding smuggling of bovines in a truck container bearing registration No. PB13BC-4295 coming from Kathua side. Acting on information, a Police team headed by SHO Police Station Samba successfully intercepted the said truck near NHW SIDCO Chowk Samba for its checking. During checking, thirty one bovines found inside the vehicle which were tied in a cruel manner and were being transported illegally without any valid permission. All the rescued bovines have been shifted to a safer place.

A case FIR No. 45/2025u/s 223 BNS, 11 PCA has been registered at Police Station Samba and investigation started. Police team of Police Station Rehambal led by its SHO while performing patrolling/vehicle checking duty at naka point Rehambal stopped one vehicle (truck) bearing registration No. JK13E- 4142 for checking purpose. During checking of said vehicle, 28 no. of bovines were found laden inside the vehicle which were tied in a cruel manner and were being transported illegally without any valid permission.

Bovine smuggler namely Sameer Ahmed, son of Mushtaq Ahmed, resident of Chamalwass, Ramban has been arrested on spot.

All the bovines were rescued and have been shifted to a safer

Police team of Police Station Udhampur led by its SHO while performing vehicle checking duty at Jakahani Naka point intercepted one vehicle (Dumper) bearing registration No. JK19A-5938 for checking purpose. During checking of the above said vehicle, 09 no. of bovines were found laden inside the vehicle which were tied in a cruel manner and were being transported illegally without any valid permission. Driver of the vehicle fled away from the spot. All the bovines vere rescued and have been shifted to a safer place.

In this regards, case FIR No. 50/2025 and under relevant sections of law stands registered at Police Station Udhampur.

In compliance to the provisions of the NDPS Act it has been ordered that these properties shall not be transferred, sold, o dealt with in any manner without prior permission the compe

drones, flying objects in the jurisdiction of District Doda "Those already in possession of drone cameras/flying objects/toys or similar gadgets are directed to deposit the same in the nearest Police Station within a week's time of the issuance of this order against proper receipt" the order issued today stated.

It further stated that the Government Departments using drones for mapping, surveys, surveillance in con struction works, agricultural, environmental conservation and disaster mitigation sectors and for creating pic tures/movies shall inform the local Police Station Incharge and the Executive Magistrate concerned in writ ing about possession of such flying objects and shall seek prior permission from the ADC office before using the

The police/defense forces using flying objects/drone shall be exempted under this order. They shall, however intimate the concerned SHO before using the same, ir added. Any violation of this order shall attract punitive action as warranted under relevant sections of law. This order shall remain in force for a period of two months from the date of its issue.

The Senior Superintendent of Police, Doda shall ensure the implementation of this order in letter and spirit.

Driver of the truck has also been arrested and shall be produced before Judicial Magistrate for further custody after Jama-Talashi, Medical and other formalities. 
