Consequent upon the reduction of merit by GOI for NEET PG Courses vide notice no. U-12021/05/2024-MEC dated 04-01-2025 of MCC, GOI and in pursuance to Notification No. 003-BOPEE of 2025 Dated 14-01-2025, the Board invited offline applications from the willing and eligible NEET- PG qualified In-Service Candidates/Doctors of UT of J&K/Ladakh for admission to Post MBBS DNB seats, Post Diploma DNB seats & Post MBBS Diploma seats (Broad Specialty) DNB Courses – 2024 w.e.f. 15-01-2025 to 17-01-2025. Accordingly, the Revised JKUT Specific Provisional Merit List of eligible candidates, who have applied for the said courses/category subsequent to lowering the percentile is hereby notified as Annexure-A to this Notification. Further if any candidate who is desirous to remove/make his/her deficiency/objection, if any, as mentioned against his/her name, may do so upto 05-02-2025 (till 04:00 p.m.) physically at the BOPEE Offices Jammu/Srinagar during the working days only, failing which no claim whatsoever shall be entertained on this account under any circumstances.

Note:

- The candidate(s) who fails to submit his/her deficient document(s) as shown against their name(s) in the Annexure-A upto 05-02-2025 (till 04:00 p.m.) as mentioned in the Notification due to obvious reasons, he/she shall, however, still be provisionally allowed to participate in the counselling process on his/her own risk and responsibility.

The Merit list notified vide notification no. 188-BOPEE of 2024 dated 12-12-2024 before reduction of percentile of DNB Courses 2024 shall no longer be applicable for prospective rounds of counselling.
