Conference Additional Secretary and Minister Kumar Sadhotra expressed deep concern over the deteriorating law and order situation in Jammu, saying that criminal elements have become emboldened, carrying out shootouts and burglaries in broad daylight. "Such brazen acts of crime

have sent shockwaves among the people, especially housewives, elderly citizens, and children, making them feel unsafe even within their own homes", Sadhotra lamented while addressing a workers meeting at Kathua which was organized by Ajit Kumar Sharma District National President Conference Kathua and Neelam Sharma Incharge Women Wing Kathua Block Basholi and K K Bakshi Sr. Vice President Kathua and Shakeel Ahmed Block President Kathua. He said that criminals appear to have no fear of law enforcement, as they continue their sinister activities against civ-

ilized society without any deterrence. This situation reflects serious lapses in policing and governance, due atmosphere of insecurity, he said while holding the BJP responsible for alarming and deteriorating situation.

In this context, Sadhotra also referred to the reports of excessive use of force and harassment of Makhan Din in police custody in Billawar leading to his suicide and the killing of Waseem Ahmed Malla, allegedly by the army under circumstances not yet entirely clear, saying such incidents instil sense on insecurity and fear among the people. PIL regarding nomination of 5 MLAs

DB directs Parties to complete pleadings before March 20, 2025 It is further submitted that vacant/unfilled are required

STATE TIMES NEWS JAMMU: In the much publicized Public Interest Litigation filed by Ravinder Sharma Former MLC of Congress challenging the power vested with the Lieutenant Governor to nominate five members to the J&K Legislative Assembly, a Division Bench (DB) of Jammu & Kashmir and Ladakh High Court comprising Justice Sanjeev Kumar and Justice Rajesh Sekhri adjourned the matter for March 20, 2025 and directed Parties to complete pleadings by the next date of hearing positively.

DB also issued notice in an application filed by Ravinder Singh retired JKAS Officer and others seeking impleadment as party.

In the application filed through Advocate Sheikh Shakeel Ahmed submitted that petitioners actually belong to POJK (Pak Occupied Jammu & Kashmir), as their ancestors

Disturbances from their original places and the applicant No. 1 originally hails from (Rawlakote). Tehsil Plandri and the applicant No.2 from Village Saver, Tehsil Bagh and their record finds mention in the records maintained by the Provincial Rehabilitation (PRO), J&K Government.

The ancestors of the applicants who were Sikhs alongwith people belonging to other faiths, underwent unprecedented stances including communal violence and finally the then Government came out with rehabilitation schemes /cabinet decisions for rehabilitation of the affected families. The aggrieved/affected migrants were initially kept in camps and slowly and slowly they were temporarily settled at various nooks and corners of the erstwhile J&K State and even some took refuge out-

side J&K.

The applicants herein are displaced persons of 1947 POJK especially fromTehsils Plandri and Bagh which are now under the illegal occupation of Pakistan and initially 25 seats had been earmarked for POJK and then one seat was defreezed in 1975 vide J&K Constitution 12th Amendment Act, 1975 and, have been reduced to 24.

The prescription/reservation of one seat for the Displaced Persons of POJK vide impugned provisos do not satisfy the political aspirations and the right of franchise of the Displaced Persons of 1947 who are externally displaced persons comprising of more than 40,000 families fromDistricts Poonch, Muzzaffarabad and Mirpur of erstwhile Princely State of Jammu & Kashmir appeared to have migrated which is presently under the illegal occupation of Pakistan and the impugned provisions

1965 and 1971 Wars and the Court may kindly appreciate that Kashmiri Migrants which is a minuscule minority are internally displaced persons which have been granted two slots, out of which one is reserved for women and the said class of persons have migrated Kashmir Province is being administered by the Govt, of India and is a part of the Union Territory of Jammu and Kashmir and on the other hand the applicants who hail from Tehsils Bagh/Plandri (POJK) which is since 1947 under the illegal occupation of Pakistan and a puppet Government installed by the Pakistan is administering the affairs of POJK and the Displaced Persons of 1947 from POJK are the worst sufferers politically, socially, economically, culturally, as their identity got vanished because of their scattered rehabilitation in different camps throughout Jammu & Kashmir and other parts of the country.

In order to ameliorate the hardships of the Displaced Persons of 1947 from POJK, the respondents should have given the due representation proportionate their sufferings and inadequate representations in various political institutions especially in J&K Legislature out of the 24 reserved seats but by virtue of the impugned provisions only one seat has been earmarked in J&K Legislative Assembly for the Displaced Persons of POJK and the applicants who are Displaced Persons of 1947 from POJK seek the kind indulgence of this Court to afford them reasonable opportunity of being heard by impleading them as party respondents or in the alternative the applicants be allowed to intervene in this matter of wide public importance. The applicants as well as other

Displaced Persons of 1947 from POJK will suffer irreparable loss and injury in case the instant application is not allowed and for the submissions made hereinabove, the applicants herein are necessary parties and for this reason, the indulgence of

this Court is warranted. It is pertinent to place before this Court the expressions and soul of the unanimous Resolution adopted by the Parliament of India on February 22nd, 1994 in which the Government of alongwith Parliamentarians belonging to every political spectrum have unanimously pledged in the August House that POJK is an inalienable part of Jammu & Kashmir and the Govt, of India is committed to get it back from the illegal PAK occupation. The Home Minister and Defence Minister have also recently reiterated the same stand of Govt, of India in various forums.

Internally Displaced Kashmiri Migrants is being protected by installing Special Polling Stations in the Kashmiri Migrant Camps in J&K and other parts of the country to allow them to vote for candidates of their choice in their respective constituencies from which they are internally displaced, whereas, in the case of Externally Displaced Persons of 1947 of POJK, no such right has been provided to them in order to get an adequate proportionate representation in the J&K Legislature especially for the 24 seats reserved in POJK areas category, thereby depriving them of their equitable right to exercise their franchise to political representation of their choice. That for securing the ends of justice qua the Displaced

Persons of 1947 from POJK,

Legislative Assembly for fulfilling the political aspirations of unrepresented category of externally Displaced Persons of 1947 from POJK. as was earlier done vide J&K Constitution 12 Amendment Act, 1975 with special reference to the people who have migrated Muzzaffarabad, Poonch and Mirpur Districts. That the Constitution of India especially its preamble speaks of justice social, economic and political and as already pointed out the applicants who are victims of neglect since 1947 nothing substantial was done to uplift their status and thi petition wherein the impugned provisions have been called question and for the just disposal of the above titled PIL, it would be just and proper in case the applicants are permitted to espouse their cause particularly the injustice meted out

to them since 1947.
