• 1st Offense: ₹ 2,000 (Households) / ₹ 10,000(Commercial/Contractors)
• 2nd Offense: ₹ 5,000 (Households) / ₹ 25,000(Commercial/Contractors)
Further violations may lead to additional enforcement action as per applicable rules.
3. C&D Waste Collection & Transportation
ULB-authorized vehicles are available for scheduled pickup of C&D waste. Citizens shall book services only through the official helpline.
