PUBLIC NOTICE

The Municipal Council Rajouri informs all residents, households, contractors, builders, and commercial establishments that proper management of **Construction & Demolition (C&D) Waste** is mandatory under the *C&D Waste Management Rules, 2016*. To ensure scientific and systematic disposal of C&D waste, the ULB has established **designated C&D Waste Collection Centers** in various wards.

- User Charges for C&D Waste**
The following user charges for collection, transportation, processing and disposal of C&D waste have been notified and enforced by the ULB:
 - Small Vehicle (up to 1 ton): ₹ 500 per trip
 - Medium Vehicle (2-3 ton): ₹ 1000 per trip
 - Large Vehicle (5-6 ton): ₹ 2000 per trip
- Penalty for Illegal Dumping of C&D Waste**
Illegal dumping of C&D waste on roadsides, open areas, drains, water bodies, vacant land, or any public place is strictly prohibited. Violations shall invite the following penalties:
 - 1st Offense: ₹ 2,000 (Households) / ₹ 10,000 (Commercial/Contractors)
 - 2nd Offense: ₹ 5,000 (Households) / ₹ 25,000 (Commercial/Contractors)
- C&D Waste Collection & Transportation**
ULB-authorized vehicles are available for scheduled pickup of C&D waste. Citizens shall book services only through the official helpline.
- C&D Waste Helpline**

- Appeal to Citizens**
The ULB urges all residents to dispose of C&D waste responsibly and support clean, safe, and sustainable waste management practices.

Government Order No. 64-JK (Edu) of 2026

Dated: 10.02.2026

Whereas, tentative seniority list of PG Masters/Teachers in the discipline of **Philosophy** was issued vide Notice dated 08.01.2024; and

Whereas, after issuance of the tentative seniority, the Department received various representations through the concerned Directorates for inclusion/updation of service particulars in the seniority list; and

Whereas, the objections received by the Department from the members of the Cadre with regard to additions/deletions/corrections have been examined thoroughly in the Department and the genuine objections have been entertained; and

Whereas, the incumbents who have obtained their PG degrees through distance/private mode during service without obtaining proper permission/leave from the competent authority and in whose favour recommendations of the designated committee in light of Government Order No. 188-JK (Edu) of 2024, dated 15.03.2024 have not been received till date, have also been incorporated in the seniority list, with the condition that their inclusion in seniority / promotion is subject to the condition that the case is recommended by the committee constituted vide Government Order No. 188-JK (Edu) of 2024 dated 15.03.2024. In case the degrees are not recommended by the designated committees, their names shall be deemed to have been deleted from the seniority list ab-initio; and

Whereas, the designated committees have recommended 71 incumbents in light of Government Order No. 188-JK(Edu) of 2024, dated 15.03.2024 who had obtained their PG degrees through distance/private mode during service without obtaining proper permission from the Administrative Department and the recommendations made in favour of 69 incumbents (**Annexure-D + Annexure-E**) have been accepted by the Competent Authority. However, the recommendation shall be deemed to have been withdrawn, ab-initio, in favour of such incumbents who do not fulfill the criteria as laid down in Government Order No. 188-JK(Edu) of 2024, dated 15.03.2024; and

Whereas, recommendations of the committee constituted vide Government Order No. 188-JK(Edu) of 2024, dated 15.03.2024 in respect of two (02) incumbents have NOT been accepted by the Competent Authority due to the reasons mentioned against each in **Annexure-F**.

Now, therefore, in terms of Rule 24 of J&K Civil Services (Classification, Control and Appeal) Rules, 1956, the final seniority list in respect of PG Masters/Teachers in the discipline of **Philosophy** forming **Annexure-A** to this order, is hereby issued, subject to the conditions that the date of birth of the incumbents recorded in the seniority list is subject to further verification from service records, also with reference to the original Matriculation certificates of all the concerned.

Moreover, nine (09) incumbents have been included in the final seniority list at appropriate places as detailed in **Annexure-B** and sixteen (16) incumbents have been deleted from the final seniority list as detailed in **Annexure-C** for the reasons as shown against each; and

Furthermore, twenty-six (26) incumbents who have been recommended by the committee constituted vide Government Order No. 188-JK (Edu) of 2024, dated 15.03.2024, conveyed by Director School Education Jammu as detailed in **Annexure-D**, shall be included in the seniority at appropriate places, as and when full authenticated service particulars of these incumbents are received from the concerned Directorate.

The seniority list so issued will be subject to outcome of writ petition(s) pending, if any, before any Competent court of law.

Besides, it is ordered that any member of the service who is either not included or is aggrieved with the position assigned to him/her in this final seniority list can file a review petition within 07 days from the date of issuance of this updated final seniority list along with supporting documents, through concerned Directorates which shall be decided on case-to-case basis. No petition shall be entertained after the expiry of stipulated time period.
