Subject: Unauthorized absence from duty – Issuance of final show cause notice.

Whereas, the case regarding your prolonged authorized absence and absconding from duties has been intimated by the Chief Animal Husbandry Officer, Kathua vide communication No:-CAHOK/Estt./2025-26/5777 Dated:- 04.02.2026, for further necessary action; and

Whereas, as per the available record, the following facts have been established:

- 1. You remained unauthorizedly absent from duty after availing 120 days Child Care Leave w.e.f. 04.09.2023 to 01.01.2024 and you had applied further extension of CCL through e-mail for about four months which was rejected by the then Livestock Development Officer, Kathua vide letter No:- LDOK/1681-83 dated:- 01.01.2024 w.e.f. 02.01.2024 to 29.02.2024 (59 days) and you proceeded on leave without obtaining proper sanction from the competent authority.
2. On 01.03.2024 you resumed and joined duty as communicated by Veterinary Assistant Surgeon, VD KeerianGandyal, Kathua vide letter No:- VD/KG/172 dated:- 01.03.2024.
3. You again applied for earned leave w.e.f. 19.03.2024 to 16.07.2024 for domestic issue after performing your duties for 18 days and the same was rejected by the then Livestock Development Officer, Kathua vide letter No:- LDOK/2082-85 dated:- 18.03.2024, in view of the Model Code of Conduct for General elections to the house of People, Lok Sabha, 2024 as per the instructions issued by the then Deputy Commissioner, Kathua's Circular No:- DCK/ADM/2023-24/3802-08 dated:- 17.03.2024, however, you were informed to apply for leave lateron.
4. Again you left the headquarters without prior permission/sanction of the leave by the Controlling Officer/Leave Sanctioning Authority and have remained unauthorizedly absent from duty w.e.f. 19.03.2024 to till date which adversely affected the functioning of the institution and disrupted the responsibilities entrusted to you.
5. Notices vide letter No:- LDOK/1795-99 dated:- 09.01.2024, No:- LDOK/1967-71 dated:- 03.02.2024, No:- LDOK/194 dated:- 29.05.2024, LDOK/639-42 dated:- 24.08.2024 and No:- LDOK/1212-15 dated:- 25.11.2024 were issued by Livestock Development Officer, Kathua with the directions to resume your duties and also provide your whereabouts and defensive document for settlement of unauthorized absence period.
6. Show cause notices were also served vide No:- LDOK/786-789 dated:- 14.10.2025, No:- LDOK/803-806 dated:- 28.10.2025, No:- LDOK/833-835 dated:- 31.10.2025 and No:- LDOK/883-886 dated 10.11.2025 by Livestock Development Officer, Kathua for remaining unauthorized absent from duty. However, you neither resumed your duty nor replied/reported to your controlling officer.

Whereas, such casual and negligent attitude towards official duties is viewed seriously and is liable to attract disciplinary action under the relevant rules.

Whereas, Government instruction (1) below Sub-rule 5 of Rule 31 of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, provide that in cases where a Government servant has unauthorizedly absented himself from duty, the proper course is to initiate action under Article 128 of the Jammu & Kashmir Civil Service Regulations; and

Whereas, Article 128 of the Jammu & Kashmir Civil Service Regulations, 1956, provides as under:-

"Absence without leave or after the end of the leave involves loss of opportunity."

Now, therefore, before proceeding further in terms of the above rules, a final opportunity is hereby afforded to you of being heard/compliance, to immediately resume your duties without any further delay and to explain the position regarding unauthorized absence from official duties within a period of seven days. Failing compliance, action under Article 128 of the J&K Civil Service Regulations, 1956, shall be initiated against you without any further notice, and in case of failure to respond, the matter shall be decided ex parte.

For and on behalf of the Lt. Governor, J&K Union Territory e-tenders are invited on percentage rate basis from approved and eligible Contractors registered with Union Territory of J&K/CPWD / BRO/ Railways/ MES and other State/ Central Government for the work mentioned below:-

1. Bids must be accompanied with cost of Tender document in shape of challan through Treasury indicating the name of work and e-NIT No. favouring Chief Accounts Officer, PW (R&B) Department, Jammu Zone by crediting to 0059-PWD (Revenue) issued after issuance of e-NIT No. & Date uploading a copy of treasury challan/receipt issued after the advertisement of e-NIT. The date on challan should be between date of start of bid submission and bid submission end date.

2. The date and time of opening of Financial-Bid shall be notified on Web Site www.jktenders.gov.in and conveyed to the bidders automatically through an e-mail message on their e-mail address. The Financial-bids of Responsive bidders shall be opened online in the Office of the Chief Engineer, PW (R&B) Department, Jammu Zone. The date for same shall be intimated separately.

3. The bids for the work shall remain valid for a period of 90 days from the date of opening of Technical bids.

4. Instruction to bidders regarding e-tendering process:- Bidders are advised to download bid submission manual from the "Downloads" option as well as from "Bidders Manual Kit" on website www.jktenders.gov.in to acquaint bid submission process.

4.2. To participate in bidding process, bidders have to get "Digital Signature Certificate (DSC)" as per Information Technology Act-2000. Bidders can get digital certificate from any approved vendors.

4.3. The bidders have to submit their bids online in electronic format with digital Signature. No financial bid will be accepted in physical form.

4.4. Bidders must ensure to upload scanned copy of all necessary documents mentioned in e-NIT and SBD as a part of technical bid.

4.5. The bidders have to raise query in writing against any clause of SBD/e-NIT only on the day/time of pre-bid meeting prescribed in the e-NIT. No objections against SBD/e-NIT shall be entertained post pre-bid meeting and the same shall be rejected outrightly without assigning any reason whatsoever.

Note:- Scan all the documents on 100 dpi with black and white option.

5. The department will not be responsible for delay in online submission due to any reasons.

6. EMD in shape of FDR/CDR/BG pledged to Chief Accounts Officer PW (R&B) Department, Jammu Zone should be 2% of the advertised cost & must be uploaded with the bid and the same shall be released after declaration of L1. The EMD shall be valid for 45 days beyond the bid validity period from the date of opening of technical bid. The earnest money shall be forfeited if:

- a. Any bidder/tenderer withdraws his bid/tender during the period of bid validity or makes any modifications in the terms and conditions of the bid.
b. Failure of successful bidder to furnish the required performance security within specified time period after issuance of letter of acceptance.
c. Failure of successful bidder to execute the agreement within the stipulated period.

7. Performance Security 3%: Within 21 (Twenty One) days after the date of receipt of the letter of Acceptance, the successful bidder/ contractor shall deliver to the Employer/concerned authority, a Performance Security in shape of CDR/FDR/Bank Guarantee for an amount equivalent to 3% of the contract price.


