



4 missing persons reunited with families

KATHUA: Jammu and Kashmir Police, Kathua under the supervision of SSP Kathua Mohita Sharma, has reunited four missing persons with their families, police officials said today.

According to a police spokesperson, the first missing complaint was filed on January 27, 2026, when Harbans Lal reported his wife Sonali (W/o Harbans Lal) R/o Barwal, Kathua missing. On February 12, another complaint was lodged by Raj Kumar regarding his daughter Roshni Devi (D/o Raj Kumar) R/o Ward No. 17, Kathua. Two more missing reports were filed on February 7 and February 18 for Vijant Kumari (D/o Mukesh Ram) R/O Jharkhand A/P Barnoti, Kathua and Umang Paudwal (S/o Anil Kumar) R/o Ward No. 03, Kathua respectively.

"Our teams at PS Kathua, led by SHO Insp. Ashish Sharma, immediately swung into action on receiving the missing persons reports," the police spokesperson told reporters. "With guidance from Addl. SP Kathua Rahul Charak, and DySP Hqs Kathua Ravinder Singh, officers conducted extensive searches, utilising both technical assistance and proactive fieldwork."

The spokesperson explained that the combined efforts of police teams and use of modern tracing tools helped locate all four individuals by February 23, 2026.

"Once traced, and after all legal formalities were completed, the missing persons were safely handed back to their legal heirs," he added. "All four missing reports have now been officially closed."

Two tractors, JCB involved in illegal extraction & transportation of minerals seized

BARAMULLA: Continuing its drive against illegal mining and unauthorized extraction of minerals, Police have seized two tractors and a JCB involved in illegal extraction and transportation of minerals in Baramulla.

A Police party of PP Palhallan seized two tractors during patrolling at New Colony Palhallan. The tractors were found involved in illegal extraction of minerals. Both vehicles were seized on the spot, and action has been initiated under the relevant provisions of the MMRD Act.

Meanwhile, a joint team of the Geology & Mining Department and Baramulla Police under the jurisdiction of Police Post Delina conducted a surprise inspection at the Kanispora area of District Baramulla.

During the operation, one JCB was found actively engaged in illegal extraction of minerals. The machinery was seized on the spot to prevent further damage to natural resources. Legal action has been initiated under the relevant provisions of the MMDR Act, and further proceedings are underway as per law.

Property of Pakistan-based terror handler attached in Billawar

KATHUA: In a legal action against cross-border terrorism and its support networks, Jammu & Kashmir Police, Kathua, under the direction of SSP Kathua Mohita Sharma, has attached an immovable property belonging to a Pakistan-based terror handler in the jurisdiction of Police Station Billawar, police officials said today.

A police spokesperson said the attachment was effected following directions from the 3rd Additional Sessions Court, Jammu, in connection with FIR No. 142/2024 registered at PS Billawar under multiple sections of the law including the Unlawful Activities (Prevention) Act (UAPA) and EIMCO Act. The property, a 7.5 marla land parcel in Khewat No. 155/152, Khasra No. 995/726, is situated in Tehsil Lohai Malhar, District Kathua.

"The attached property belongs to Swar Din @ Swaru (S/o Ami Din), R/o Bhatodi, Tehsil Lohai Malhar, District Kathua, who has been identified as a terror handler currently operating from across the border in Pakistan," the spokesperson said. "He had exfiltrated to Pakistan/PoJK and was actively involved in activities prejudicial to the security and sovereignty of India, compelling the court to declare him a proclaimed offender after sustained efforts to secure his arrest proved unsuccessful."

Acting on the court's order, the attachment was carried out by SHO Police Station Billawar Insp. Zaheer Mushtaq, under the guidance of SP Operations Upper Kathua Ammir Iqbal and SDPO Billawar Neeraj Padyar, in close coordination with the Revenue Department following all legal verification and documentation protocols.


"This decisive action forms part of a broader strategy by J&K Police to dismantle the financial and logistical support structures of terror networks," the spokesperson added. "By depriving individuals involved in terrorism of their resources, we reinforce our commitment to peace, security and national sovereignty."
