SHOW CAUSE NOTICE

Whereas, you were appointed as Orderly vide Order No. DSS/12 of 2013 dated 16-04-2013 in the erstwhile Stationery and Office Supplies Department, J&K. As per service records, soon after your appointment, you started remaining unauthorizedly absent from duty on repeated occasions. Instead of initiating immediate major penalty proceedings at the initial stage, the Department adopted a reformative and humanitarian approach by issuing explanations and warnings, and placing you under suspension, followed by reinstatement upon your assurances of improved conduct. Certain spells of your absence were also regularized as earned leave or other admissible leave, wherever found permissible under the rules. However, despite repeated opportunities and lenient treatment, you failed to show any lasting improvement, as each reinstatement was followed by further unauthorized absence, thereby establishing a persistent pattern of indiscipline and disregard for official responsibilities.

Whereas, again vide Government Order No. 80-JK (ARI & Trgs) of 2021 dated 11-08-2021 you were placed under suspension for unauthorized absence and attached with the Administrative Department, Civil Secretariate, Jammu and whereas, you submitted an undertaking/affidavit dated 20-06-2022 that you will remain punctual and regular in future, failing which the Department would be at liberty to initiate action against you;

Whereas, consequent upon the winding up of the Stationery & Office Supplies Department, you were deployed to Ranbir Government Press, Jammu vide Government Order No. 24-JK (ARI & Trgs.) of 2022 dated 24-08-2022; and whereas, on the recommendation of the General Manager, Ranbir Government Press, Jammu, you were reinstated vide Government Order No. 02-JK (ARI & Trgs.) of 2023 dated 20-01-2023 with a clear warning to remain cautious and duty-bound in future;

Whereas, despite the aforesaid warning, you were again involved in misconduct and were placed under suspension vide Office Order No. 07 dated 15-04-2023; and whereas, since then, you have continued to remain on unauthorized absence and have been absconding from duties;

Whereas, you were served a Show Cause Notice vide No. RGPJ/EC/1979-82 dated 29-08-2023, followed by a Final Show Cause Notice vide No. RGPJ/EC/7759-62 dated 25-01-2024 issued by the General Manager, Ranbir Government Press, Jammu, which were also published in the print media; however, despite the aforesaid notices and publication, you have neither resumed your duties nor submitted any reply, and continue to remain on unauthorized absence till date;

Whereas, vide Government Order No. 32-JK (ARI & Trgs.) of 2024 dated 05-09-2024, Regular Departmental Action was initiated against you under the provisions of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956 on account of habitual and prolonged unauthorized absence from duty and allied misconduct;

Whereas, a detailed enquiry was conducted after examining the relevant records, notices, suspension orders, explanations furnished, affidavits/undertakings submitted by you, and other connected correspondence; and whereas, the Enquiry Report has conclusively held that you have habitually and wilfully remained unauthorizedly absent from duty, failed to comply with lawful orders directing you to resume duties, and failed to reform despite repeated opportunities and lenient treatment extended by the Department;

Whereas, the findings further indicate that your conduct reflects gross negligence, lack of devotion to duty, and conduct unbecoming of a Government servant, and that your continuation in service does not appear to be in public interest;

Now, therefore, in terms of the provisions of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the Department proposes to impose upon you a major penalty, including termination from service.

Therefore, in view of the above, you are hereby called upon to show cause as to why the aforesaid proposed penalty should not be imposed upon you. Your reply, if any, must reach this office within ten (10) days from the date of receipt of this notice. In case no reply is received within the stipulated period, it shall be presumed that you have nothing to state in your defence and further action, as warranted under the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, shall be taken against you accordingly.
