

DC Reasi reviews works under RDD, Shiv Khori Shrine Board Projects

REASI: Deputy Commissioner Reasi, Kumar Abhishek chaired a review meeting to assess the progress of works being executed by the Rural Development Department under District CAPEX and key flagship schemes, including Pradhan Mantri Awas Yojana (Gramin) and Swachh Bharat Mission (Gramin). He also conducted a detailed block-wise review of ongoing rural development projects across the district.

The DC instructed the concerned officers to prepare management plans for Common Service Centres, compost pits and grey water management, stressing the need to improve sanitation and wastewater systems. Emphasizing timely delivery, the DC called for the expeditious completion of all pending PMAY (G) houses and close coordination between Block officers and the engineering wing.

Officers were further asked to prepare comprehensive plans for new projects, covering all stages from initiation to completion, ensuring quality and efficiency.

Later, the DC reviewed ongoing developmental works under the Shri Shiv Khori Shrine Board,

assessing the progress of key infrastructure projects. The concerned officers briefed him on the status of works following which he directed the executing agencies to adopt measures to accelerate progress.

He emphasized on maintaining quality standards, adhering to timelines and ensuring effective coordination among all departments involved.

The meeting was attended by SSP Paramvir Singh, ADDC Sukhdev Singh Samyal, ACD Vijay Kumar, CPO Narinder Kumar, Executive Engineer (REW), BDOs and other concerned officials.

Whereas, it appears to the Government of UT of J&K that land measuring 11 Kanals 08 Marias is required for Defence purposes for construction of Axial Road from BOP (Suresh) to Fence at village Nanga, Tehsil Ramgarh District Samba. It is as such hereby notified that land in the area specified is required for the above purpose;

This notification is made under the provision of Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 to all whom it may concern.

In exercise of powers vested in me under section 11 Sub Section (1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, I, Sandeep Dubey (JKAS), Collector Land Acquisition Vijaypur do hereby Notify that the land particular of which are given herein below is required for Defence Purposes for construction of Axial Road from BOP (Suresh) to Fence at village Nanga, Tehsil Ramgarh District Samba.

Further, under section 11 (4) of the Act no person shall make any transaction or cause any transaction of land i.e. sale/purchase etc. or create any encumbrance on such land from the date of publication of this notification without prior approval of the Collector.

Objections to the acquisition if any may be filed by the person(s) interested within sixty days from the date of publication of the notification as provided under section 15 of the Act, before the Collector Land Acquisition, Vijaypur.
