Now, therefore, in exercise of the powers vested in me under section 163 of Bharatiya Nagarik Suraksha Sanhita (BNSS), I, Dr. Rakesh Minhas (IAS), District Magistrate, Jammu hereby impose restrictions on assembly of 5 or more persons within a radius of 100 meters in all the 05 notified examination center shall be strictly prohibited from 08:00 AM to 06:00 PM (except authorized personnel) on 08.02.2026. Since it is not possible to serve the order individually, it shall be circulated in print and electronic media for information of all concerned and is hereby issued ex-parte.

Any person who contravenes this order shall be liable to be punished in accordance with the provisions of Section-223 of Bharatiya Nyaya Sanhita (BNS).

ORDER

1. Investigating officer of the case DySP Farah Nishat present in person. An application has been moved by the I.O. seeking issuance of proclamation against the accused Mohd. Tariq S/o Mohd. Ayoub R/o Kallar Kattal, Surankote, Poonch in connection with FIR no. 245/2025 u/s 67(A) IT Act 351 (3)/ 352/ 356(2)/ 61(2)/ 59/ 79 BNS against whom already a warrant of arrest u/s 75 of BNSS was issued by this court on 23.01.2026 and said warrant has returned unexecuted.

2. A perusal of the case diary shows that warrant of arrest u/s 75 BNSS was issued against accused on 23.01.2026 for securing his presence during the investigation and the said warrant has remained unexecuted. The executing officer have reported that the accused had already left the country and from last three four months he is residing in Saudi Arabia at an unknown place. In view of the above circumstances, this court is satisfied that the conditions prescribed u/s 84 BNSS are duly fulfilled. The unexecuted warrant u/s 75 BNSS, coupled with the report of executing agency, establishes that the accused is intentionally avoiding the execution of warrant.

3. Accordingly, proclamation u/s 84 BNSS is hereby ordered to be issued against the accused Mohd. Tariq S/o Mohd, Ayoub R/o Kallar Kattal, Surankote, Poonch requiring him to appear before this court within 30 days from the date of publication of the proclamation failing which appropriate proceedings in accordance with law shall follow. The investigating officer shall get the proclamation published in local daily newspaper having wide circulation besides publishing 'the said proclamation in the manner as provided u/s 84(2) BNSS. The Investigating Officer is directed to comply with the above directions and to submit a compliance report along with photographs on or before next date of hearing. Put up for report/compliance on 12.03.2026.

2. **Cost of Tender Document:** Bids must be accompanied by a Treasury Challan (dated between the bid start date and the Bid Submission End date) deposited in M.H. 0059 (Revenue) mentioning their name of work/e-NIT No. pledged to Executive Engineer PW(R&B) Division Chatroo (Tender Inviting Authority) as the cost of the tender document. Any deviation in the specified amount, the bid shall be rejected outrightly. The cost of Tender Document is non-refundable.

3. **Earnest Money Deposit/ Bid Security:** At the time of tendering, all bidders must upload Earnest Money/ Bid Security equal to 2% of the Advertised Cost (Required amount only not above or below). strictly as stipulated above against work/e-NIT No. pledged to Executive Engineer PW(R&B) Division Chatroo (Tender Inviting Authority) as the cost of the tender document. Any deviation in the specified amount, the bid shall be rejected outrightly.

3.1. Bid security of the unsuccessful bidders shall be released only after the submission of Treasury Challan Bid security of the unsuccessful bidders should be returned to them at the earliest after expiry of the final bid validity and latest on or before the 30th day after the award of the contract.

3.2. The Earnest Money/ Bid Security of 2% will be released to the successful bidder only after the submission of a Performance Security.

4. **Performance Security:** The successful bidder will have to provide Performance Security @ 5% of the value of contract cost (quoted bid), in addition to the bid security in the shape of CDR/FDR/BG pledged to Executive Engineer PW(R&B) Division Chatroo (dated after issuance of Letter of Award), mentioning the name of work/e-NIT No. at the time of contract award within 07 days of the issuance of L.O.A, strictly in accordance with the Government's circular instructions from time to time and Financial rules. 6. The additional performance security shall be released only after successful completion of work. The additional performance security of unsuccessful bidder shall be released in a week's time after technical evaluation.

7. **Financial Bid Opening** The date and time of opening of Bids shall be notified on Web Site www.jktenders.gov.in and conveyed to the bidders automatically through an e-mail message on their e-mail address. The bids of Responsive bidders shall be opened online on same Web Site at the office of the Executive Engineer, PW(R&B) Division Chatroo

7.1. In case the lowest tendered amount (estimated cost + amount worked on the basis of percentage above/below) of two or more contractors is same, such lowest contractor will be asked to submit revised offer in the form of letter mentioning percentage above/ below on estimated cost of tender including all sub sections/sub heads as the case may be, but the revised percentage quoted above/below on tendered cost of one each sub section/sub head should not be higher than the percentage quoted at the time of submission of tender. If the revised tendered amount of two or more contractors received in revised offer is again found to be equal, the lowest tender, among such contractors, shall be decided again by further sealed revised offers in the presence of Engineer, PWD(R&B) Division Chatroo & the lowest contractors those have quoted equal amount of their tenders

7.2. If any of the lowest contractors those have quoted same tendered amount (estimated cost + amount worked on the basis of percentage above/below), refuse to submit revised offer, then L1 bidder shall be selected who has given revised offer and such revised offer shall meet up all condition as stipulated in clause 6.1.
