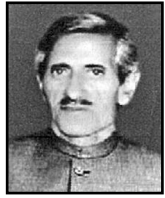

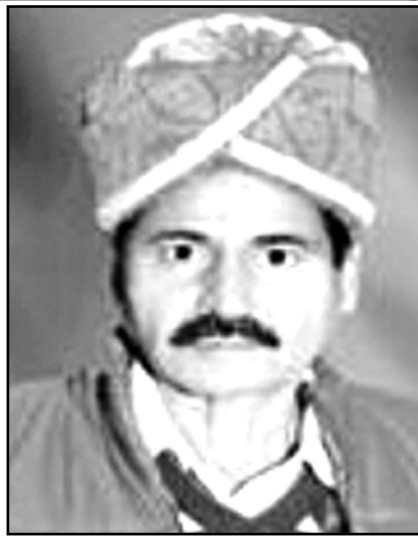

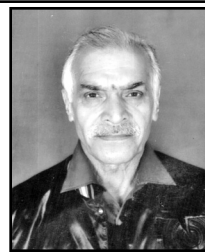

Farooq not to decide fate of BJP, people will: Parneesh

JAMMU: Castigating National Conference Patron for his remark expressing doubt on BJP forming next government in J&K, Parneesh Mahajan, Convener, Department of Training, BJP, J&K asserted that it is not Farooq Abdullah who will decide the fate of J&K but the 'all powerful' people will vote BJP to power looking into party's nationalistic policies.

In a statement issued here on Wednesday, the BJP leader said that under the guise of being 'Political Ptmidit' Farooq Abdullah is making a futile attempt to save his sinking ship viz the National Conference, which has no more takers whether in Kashmir, Jammu or anywhere else. He categorically said that the deceitful policies of Farooq Sahib through which he used to befool people in different regions by toeing different lines on religions, regions, language and ethnicity suiting his pursuits before different class of audience and places shall work no more as he has been exposed at all fronts and people know well NC's ploy to mislead them again and again. The senior BJP leader made it clear that the time has gone

when shrewd politicians used to make fool of people as BJP has shown the world that how a political outfit can change the course of life of people by way of selfless service by its ground level activists. He said the pace of development which is currently being witnessed in the J&K is the simple model of BJP having no match in J&K or even India.

"People can't afford to opt for conventional parties which never see beyond their clans and personal gains when there is a best option available in the shape of BJP promising clean and good governance", he maintained.

Mahajan said that those expecting vice versa in upcoming Assembly elections are day dreaming because it is BJP which will emerge as the single largest party and form the next government in the UT with majority of opposition candidates forfeiting their security deposits. He said that propaganda by NC, PDP or Congress will never succeed as the case was in recent DDC polls, where also the BJP came out shining with maximum of its candidates showing doors to opponents.

Bring changes in precedence list, stop undermining DDCs, Congress to Govt

SRINAGAR: Jammu and Kashmir Pradesh Congress Committee (JKPCC) on Wednesday termed the J&K Government's order of placing DDC chairmen, vice-chairmen and members at bottom of precedence list as unfortunate and betrayal with the elected representatives in J&K.

In a statement issued to press, JKPCC President G.A Mir lashed out at BJP Govt for miserably failing to strengthen the Panchayati Raj Institution, saying that the untruthful slogan and promises with regard to empowering democratic institutions has once again exposed the mindset of BJP Govt. Mir strongly urged the

Government to make immediate necessary changes in the precedence list, ensuring that DDC chairmen, vice-chairmen and members exercise their authority for which they have been chosen and authorized to work for the welfare of people.

"We are committed strengthen the Panchayati Raj Institutions (PRIs) at all levels. Mir added and said Govt must stop undermining the authority DDCs and other democratic institutions, in the larger interest of common people. The precedence list issued by the Govt amounts to undermine the authority of vital institution (DDCs) of public importance, which deserves to be rectified, very immediately," G.A Mir said.
