

# Congress only alternative to BJP: Rajni Patil

JAMMU: Senior AICC Leader Incharge Jammu and Kashmir Rajni Patil, Member Rajya Sabha said that people are fed up with BJP's poor performance, opportunist and wrong policies and there is strong wave of change among Jammu people, who are looking towards congress as only viable alternative. She said congress is only viable alternative to BJP which has utterly failed on all fronts and snatched the statehood, dignity and rights, employment and trade of people.

While addressing an impressive gathering of congress workers at Shakti Nagar, organized by PCC General Secretary Mammooh Singh, Patil said that BJP has snatched atmosphere of peace, harmony and progress and downgraded the historical state against the wishes of people. Only congress can restore peace, harmony, progress especially the lost status and dignity of people of Jammu and Kashmir, she added. "Power hungry BJP's divisive and opportunist politics have destroyed and vitiated the atmosphere of peace, harmony and progress in the society, for which people will have to join the congress struggle to restore things back on rails," said Patil, advising party leaders to recognize hard work of grass root workers who alone can take congress achievements and programmes to people and bring party back to power.

She said that Congress is only political force in the country consistently playing role of healthy opposition to highlight issues of each section and opposing anti-poor, anti-farmers and anti-people policies of BJP.

KPCC Chief G A Mir raised strong pitch on the issue of restoration of histor-

ical Dogra state of Jammu and Kashmir, which was snatched from people, arbitrarily and undemocratically. He asserted that people would return the betrayal and deception of BJP with cross section of society by bringing about change whenever elections held and claimed that congress would emerge single largest party and form next government in Jammu and Kashmir.

Yogesh Sawhney appreciated workers and efforts of Mammooh Singh to hold



# Court directs ACB to register FIR against revenue officials for tempering records

JAMMU: Additional Sessions Judge, Ritesh Kumar Dubey on Wednesday directed Police Station ACB to register FIR against the then Tehsildar Jammu, Naib Tehsildar Muthi and Patwari Barnai under section 156 (3) of CrPC for abusing official powers to provide undue benefit to accused persons by tempering revenue records and initiate investigation as per procedure.

As per the details of case, one Pardeep Singh, son of Late Hans Raj, resident of village Lower Barnai Tehsil Jammu North alleged that among accused persons namely Chanchal Singh, son of Late Om Parkash, resident of village Lower Barnai, Dewan Chand, son of Om Parkash, resident of Shakti Nagar and her wife Suman, Ranjit Singh, Yash Paul, Sham Singh and Angrez Singh all sons of Chanchal Singh, resident of village Lower Barnai, accused No. 2 and 3 sold 7 Kanals, 14 Marlas and 8 Kanals of orchard land

respectively, in Khasra No 341 at Barnai, through two sale deeds without permission of the then Revenue Minister despite a prohibition on the same under J&K Prohibition on Conversion of Land and Alienation of Orchards Act 1975.

Adv Vijay Singh Bali, appearing for applicant pleaded that a bare perusal of Fard Intekhab Jamabandi shows that word 'Bagicha' (Orchard) has been erased with a criminal intention to get sale deeds registered. The accused, in conspiracy with Tehsildar Jammu, Naib Tehsildar Muthi and Patwari Barnai tempered the Fard Intekhab Jamabandi, by erasing word 'Bagicha'. Moreover revenue officers also tempered Fards by inserting that land was in form of Banjar Qadeem, when Fards were renewed in May 1998, but in reality land was actually covered by fruit trees and was correctly recorded as Bagicha Nehri. Mutations were entered on basis of four sale deeds

which were challenged by the complainant before Divisional Commissioner Jammu who stayed the operation of mutation vide order date March 21, 2019, with a further order not to change nature of land. But accused, destroyed fruit bearing trees except a Mango tree, and revenue officers issued Fard wrongly, in violation of the provisions of alienation of land Act, Orchard Act, and J&K Agrarian Reforms Act.

On this, when complainant submitted a complaint to Director ACB, he directed ADC (DVO) Jammu to furnish enquiry report in matter but no FIR was registered against guilty persons. DVO (ADC) Jammu submitted its report dated March 3, 2021 before the court stating that land fell in the category of Orchard in Terms of section 2 (2) of J&K Prohibition on Conversion of land and Alienation of Orchards Act 1975 and Alienation of Orchard Act 1975, and transfer by way of sale was not permissible, and word

Bagh had been attempted to be obliterated, just by showing only Nehri in Fard Intekhab and even then FIR was not been registered.

After hearing both the sides, the court observed that after perusal of application, status report submitted by SSP ACB Jammu and copy of a report dated 03-03-2021 submitted by Additional DC (DVO) Jammu, the Court is of the opinion that sale for the aforementioned land was not permissible at that time and concerned Patwari, Naib Tehsildar and Tehsildar Jammu, facilitated the sale of land meant for orchard, between two families, to obviate due procedure of law. "Report by revenue officer Additional DC ex-officio DVO Jammu, prime facie discloses abuse and misuse of power by the concerned revenue officers, and so, a cognizable offence under section 156 (3) of CrPC. Accordingly, SHO Police Station ACB (Jammu) is directed to lodge FIR in the case and conduct the investigation under law," the Court directed.

# CISF personnel save man attempting to commit suicide at Delhi airport

JAMMU: Over Rs. 150 crores have been planned to be spent on various infrastructural activities in higher education in the coming year. These activities include not just upgradation of physical infrastructure but other activities also such as faculty development, research centres and innovation hubs. This was revealed at a meeting at Civil Secretariat chaired on Wednesday by Principal Secretary Higher Education, Rohit Kansal to review the status of various components under Rashtriya Uchchatar Shiksha Abhiyan (RUSA) Scheme.

The meeting was attended by Vice Chancellor Jammu University, Prof Manoj Kumar Dhar, Mission Director RUSA, Dr Syed Sehrish Asgar, Managing Director J&K Projects and Construction Corporation, Rajesh Kumar Shavan, Director Planning HED, GM

Ganai, and other concerned officials.

A detailed discussion was held regarding the different projects undertaken under RUSA Scheme which include various projects in Jammu University, Govt College of engineering & Technology (GCET) Safapora and GCET Janglot Kathua.

While reviewing the physical and financial status of projects of Jammu University under RUSA Scheme, the Principal Secretary asked the varsity to furnish all the details of work done as well as

fresh proposals under Rs 100 Crore grants, besides directing them to submit the latest physical and financial activities to MD RUSA for further submitting it to Ministry of Education, Government of India.

Regarding the status of works at GCET Safapora, he directed MD JKPC to submit a proposal of pending works or additional works for timely completion of the vital project in Higher Education map of J&K. Similarly, with regard to GCET Janglot, Kansal asked the concerned

During the meeting, Kansal sanctioned Rs 10 Crore for Research Tower at Jammu University, of which Rs 5 crore would be granted under CAPEX Budget during next financial year. He also reaffirmed Government's commitment in research infra-

pace up all the pending works at earliest for subsequent hand over of the project by April ending this year.

Further he impressed upon the concerned to be proactive in completion of projects and to further expedite submission of the utilization certificates. He also directed MD RUSA to review all works under the domain of the scheme and remove all bottlenecks for early completion of the projects within given timelines.

The meeting also reviewed the physical and financial status of pending works under RUSA I and other civil works under different components of the scheme.

During the meeting, Kansal asked MD RUSA to prepare a draft list of projects so that proposals could be subsequently prepared according to the need of the higher education institutions and colleges and submitted to the Ministry of Education.
