KATHUA: District Development Council Kathua Chairman, Col Mahan Singh (Retd), while urging the PRI representatives to achieve financial sustainability and self reliance by creating assets, has emphasized upon the need for according top priority to the goal of sustainable development.

He stated this while addressing a special session of District Development Council Kathua that had commenced on 7th March 2022 and concluded at the District Headquarters Conference Hall here today.

The special session that was chaired by the District Development Council Chairman, Col Mahan Singh (Retd.) discussed and deliberated upon the plans and proposals to be included in District Capex Plan for the

financial year commencing on 1st April 2022. The session was attended by all the District Departmental heads who gave detailed presentation and briefing about the ongoing projects, works and proposals for the forthcoming Capex plan.

The DDC Chairman, Vice Chairman and Members remained present during the session for all the three days and proactively discussed fiscal issues and plans pertain-

ing to their respective constituencies. It is pertinent to mention here that the budget ceiling allocated during last financial year has so far benefited a lot and the PRIs have been asked to prepare their plans accordingly.

Addressing the session, the DDC Chairman Kathua said that owing to various issues in tendering system during the ongoing financial year, the PRI share of funds is likely to be spent upto 80-90%.

He said that problems experienced in achieving 100% expenditure of funds allocated this year will be adequately addressed while implementing next year's plan. He reminded them that the Govt has fixed 15th March as cut of date for preparing next year's plan by the respective Districts and all out efforts should be made to finalize the same before the due date.

Col Mahan Singh (Retd) urged the PRI representatives to ensure that the plans prepared by them are inclusive and moreover these should cumulatively guarantee the achievement of sustainable development goal to which the nation stands committed. He said that there is a dire need for the Panchayats to work relentlessly in order to achieve financial sustainability and self reliance by creating assets.

Residents majority of them belonging to poor Tribal Gaddi and Sippi communities of Panchayt Butla, which is locat-

ed at a distance of 10 Km east of Bhadarwah across Neeru river were living in constant danger of getting drowned as they have no other option but to cross the river on torned wooden planks to reach the town and in absence of proper foot Bridge several precious lives were lost as despite running from pillar to post successive governments failed to provide them a safe bridge.

Locals said that we need a bridge with 24 meter span to reach the town but authorities are constructing only 18 meter which will not provide any relief during rainy season as the water level rise many folds at
