Consequent upon declaration of the NEET UG-2021 result by the National Testing Agency on 01-11-2021, and to update the category status vis a vis preparation of the Provisional UT Merit List of registered candidates for admission to BAMS/BUMS/BPT courses 2021, it is hereby notified that the candidates who have secured the minimum qualifying marks in NEET UG -2021 shall be required to register themselves and upload the following documents with effect from 03-03-2022 to 07 -03-2022: -

- NEET –UG score card 2021
- 10+2 marks card.
- Domicile Certificate of UT of J&K (ST Category Certificate in respect of candidates belonging to the UT of Ladakh).
- Category Certificate, wherever required.
- Date of Birth Certificate (Matriculation).

The cut-off score for different categories as notified by NTA is as under:-

- Open Merit (including EWS/JKPM/Child of PMF/CDP/Sports) =138 (50th Percentile)
- Open Merit/EWS-Handicapped/PWD =122 (45thPercentile)
- SC/ST/RBA/ALC/IB/OSC/PSP(For J&K/ Ladakh) =108 (40th Percentile)
- SC/ST/RBA/ALC/IB/OSC/PSP-Handicapped/PWD =108 (40th Percentile)

The tentative NEET Score list of candidates of J&K, who have appeared in the NEET UG 2021 has already been notified by the Board vide Notification No.127-BOPEE of 2021 dated 15.11.2021 and Notice No 082-BOPEE of 2021 dated 02.12.2021, which are available on the BOPEE website viz www.jkbopee.gov.in only. Mobile phones should not be used for registration purposes for uploading of documents, as software will not accept-ed the same.

The e-Information Brochure for NEET UG BAMS/BUMS/BPT 2021 courses has already been uploaded on website of the Board .The candidates are advised to go through the brochure before registration. The tentative schedule for registration etc. is as under:

- **Online registration/uploading of documents: 03-03-2022 to 07-03-2022**
- **Notifying of Tentative Provisional Merit List: 09-03-2022.**
- **Online filling up of Preference Forms shall be notified separately.**

Note:

- No under process certificates shall be entertained.
- The category certificates issued only up to the last date of registration shall be entertained. Any certificate issued after the registration date shall not be entertained by the Board under any circumstances.
- The candidate must fulfill all the criteria as laid down in the NEET-UG 2021 information brochure of the NTA and Information Brochure of BOPEE in respect of NEET UG,2021 courses;
- Any candidate found ineligible at any point of time shall not be allowed to participate in the counselling process notwithstanding the registration/NEET qualifying score fixed by the Ministry of Ayush; Government of India;
- The candidates should upload their valid e-mail address/mobile numbers as all important communications shall be made with them on such e-mails/mobile numbers provided by them; whenever required by the Board;
- Candidates in their own interest, are advised not to share login password with other candidate/ person;
- Board shall not be responsible for any mistake committed by the candidates, while making registration;
- After completion of the registration process, Board shall notify the provisional UT Merit List of all the candidates, which shall be used for Online or Offline counseling (as may be decided by the Board) by the candidates (filling up of the preferences) based on which allotment of seat shall be made;

Consequent upon the declaration of NEET UG,2021 result by the National Test Agency(NTA) on 01.11.2021 and subsequent Notifications / Notices issued by the Board with regard to verification of documents / filling up of online preference forms and other actions including Notification of Sports merit candidates notified vide Notice No.001-BOPEE of 2022 Dated 12-01-2022 , due application of reservation rules including Rule -17 of SRO 294 of 2005 dated 21-10-2005 as amended from time to time and on the basis of merit cum preferences, the list of candidates provisionally selected for undergoing MBBS/BDS Courses (2021) in various Colleges of the UT of J&K, is hereby notified as per **Annexure “A”** to this Notification, which shall be available on the official website of the Board viz www.jkbopee.gov.in only. The candidates shall report to the colleges allotted to them w.e.f 28-02-2022 to 03-03-2022 upto 3.00 P.M either through online or offline mode along with necessary documents including the following for admission:-

- Date of Birth Certificate (Matriculation).
- Marks Card of 10+2.
- Domicile Certificate.
- Category Certificate, if any.
- Valid Income Certificate in respect of Poor & Backward Category candidates.
- NEET Score Card 2021.
- Compulsory Service Bond by the candidates belonging to the UT of Ladakh (Proforma ofthe Bond is annexed with Notice No. 084-BOPEE of 2021 dated 16-12-2021 which is available on website of the Board).
- Any other document as may be required by the college authorities concerned.

The candidates who have been allotted Government/Private colleges in accordance with their online preferences in order of merit, shall mandatorily have to join against their provisionally allotted college / seat(s) upto 03-03-2022 positively and in case any candidate who fails to join against his /her allotted seat(s) shall not be eligible to participate in 2nd round of up-gradation/allotment counselling under any circumstances.

The candidates who figure in the Provisional Merit List (PML), but have not participated in the first round of online counseling shall be eligible to participate in the 2nd round of physical counseling as and when notified by the Board after deposition of Rs.1500/- as nonrefundable counselling fee through POS Machines which shall be available at BOPEE office Srinagar/Jammu.

The candidates who did not get a seat during online round of counseling shall also be eligible to participate in the 2nd round of physical counseling.

It shall be sole responsibility of the college concerned to ensure proper check and verification of documents before the candidate(s) is allowed for admission and in case of any discrepancy in the requisite documents, the same shall be reported to the Board for further course of action under rules.

As mandated by the NMC/MCI/DCI regulations, the colleges shall keep their admission counters open even on Gazetted holidays/off days/ Sundays especially Admission Section and designate Nodal Officers to facilitate the candidates in the process of admission. However, the candidates should, in their own interest, avoid waiting for the last day to complete the admission formalities; as such delay has the potential of causing hardships to the candidates only.

After the last date of joining, the unfilled seat(s), if any, shall be communicated to the Board by the college(s) concerned, including those unfilled seats under Hindu Minority Quota and NRI Quota in ASCOMS and IDS which shall be filled up in 2nd round of counseling for which the date (s) shall be notified separately.

The Heads of the Colleges/Institutions shall furnish the short fall, if any, by 03-03- 2022 upto 5.00 P.M to enable the Board to take further necessary action in the matter.

Note:

- Rule 17 of the Reservation Rules 2005 has been duly applied and is reflected against such candidates wherever it has been applied.
- The admission of the candidates is purely provisional and shall be liable to be cancelled in case any information furnished by any candidate proves to be false/fabricated, and action as warranted under law shall be initiated against such candidates.
- In accordance with the provisions of Rights of Persons with Disabilities Act 2016, the horizontal reservation of 4% to PWD eligible candidates has been provided in terms of SO 127 of 2020 dated 20.04.2020.
- The Colleges / Institutions concerned shall ensure that, any candidate(s) with disability, if selected in open merit or some reserved category, constitute a special Medical Board to assess such candidates and make recommendations based on which college shall take further necessary action. In case any such candidate does not fulfill the bench mark of eligibility, he/she shall not be admitted to the course/college and the matter shall be reported to the BOPEE.
- Physical Reporting**
The candidates can report to the allotted college physically for admission after paying necessary fees and submission of original documents (subject to verification of all necessary documents/certificates by the respective colleges) by following COVID-19 Protocol/ guidelines issued by the UT Government of J&K from time to time.
